AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled 2 "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 5 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 7 Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative 8 9 departments, boards, and commissions; defining the powers and 10 duties of the Governor and other executive and administrative officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the 12 Governor, Lieutenant Governor, and certain other executive 13 14 and administrative officers; providing for the appointment of 15 certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, 16 17 and commissions; and prescribing the manner in which the 18 number and compensation of the deputies and all other 19 assistants and employes of certain departments, boards and 20 commissions shall be determined, " clarifying certain 21 provisions for the approval or disapproval of regulations by 22 the General Assembly. 23 The General Assembly of the Commonwealth of Pennsylvania 24 hereby enacts as follows: 25 Section 812.2, act of April 9, 1929 (P.L.177, Section 1. 26 No.175), known as "The Administrative Code of 1929," added

October 8, 1980 (No.146), is amended to read:

- 1 Section 812.2. Legislative Approval or Disapproval;
- 2 Effect. -- A copy of every rule or regulation or amendment to a
- 3 rule or regulation proposed by the Bureau of Professional and
- 4 Occupational Affairs or any board or commission thereunder in
- 5 order to implement any provision of section 812.1 shall [before
- 6 adoption be forwarded to the Speaker of the House of
- 7 Representatives and to the President pro tempore of the Senate
- 8 for referral to and review by the appropriate standing committee
- 9 of the House of Representatives and of the Senate as determined
- 10 by the respective presiding officer. The standing committee
- 11 shall, within sixty days from the receipt of such proposed rule,
- 12 regulation or amendment approve or recommend disapproval to the
- 13 House of Representatives or the Senate of any such proposed
- 14 rule, regulation or amendment. Failure of the standing committee
- 15 to recommend disapproval and of the House of Representatives and
- 16 Senate to disapprove any proposed rule, regulation or amendment
- 17 within the review time shall constitute approval thereof. If the
- 18 standing committees of both the Senate and the House of
- 19 Representatives recommend disapproval and the House of
- 20 Representatives and the Senate disapproves any proposed rule,
- 21 regulation or amendment, the bureau, board or commission shall
- 22 not adopt the proposed rule, regulation or amendment and it
- 23 shall not be again offered for one year. Only in the absence of
- 24 a disapproval the bureau, board or commission shall proceed with
- 25 the adoption of the rule, regulation or amendment in accordance
- 26 with section 202 of the act of July 31, 1968 (P.L.769, No.240),
- 27 referred to as the Commonwealth Documents Law. be] be submitted
- 28 to the Secretary of the Senate and the Chief Clerk of the House
- 29 of Representatives who shall cause the rules or regulations to
- 30 be printed and distributed among all members of both chambers in

- 1 the same manner as a reorganization plan. If both bodies fail to
- 2 act within sixty days of receipt of such rules or regulations,
- 3 or within ten legislative days after receipt, whichever shall
- 4 last occur, rules or regulations adopted by the appropriate
- 5 professional or occupational board, or the Bureau of
- 6 Professional and Occupational Affairs shall be promulgated
- 7 pursuant to the provisions of the act of July 31, 1968 (P.L.769,
- 8 No.240), referred to as the Commonwealth Documents Law and 45
- 9 Pa.C.S. Part II (relating to publication and effectiveness of
- 10 Commonwealth documents). If either chamber disapproves any rule
- 11 or regulation, such information shall be certified by the
- 12 Speaker of the House of Representatives or President pro tempore
- 13 of the Senate to the appropriate professional or occupational
- 14 board, or the Bureau of Professional and Occupational Affairs,
- 15 and such rule or regulation shall not be promulgated as a final
- 16 rule or regulation.
- 17 Section 2. This act shall take effect immediately and shall
- 18 be retroactive to October 8, 1980.
