AN ACT

- 1 Amending the act of June 3, 1937 (P.L.1225, No.316), entitled
- 2 "An act concerning game and other wild birds and wild
- animals; and amending, revising, consolidating, and changing
- 4 the law relating thereto, " requiring a certificate of
- 5 competency for certain hunters.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 301.1, act of June 3, 1937 (P.L.1225,
- 9 No.316), known as "The Game Law, added March 28, 1968 (P.L.75,
- 10 No.30), is amended to read:
- 11 Section 301.1. [Licenses for Persons Under Sixteen]
- 12 <u>Certificate of Competency</u>.--(a) No hunting license shall be
- 13 issued to any person [under the age of sixteen years] unless he
- 14 presents to the person authorized to issue such license either
- 15 (i) evidence that he has held a hunting license issued by the
- 16 Commonwealth of Pennsylvania or another state in a prior year,
- 17 or (ii) a certificate of competency as provided in this section,
- 18 or (iii) a sworn affidavit signed by the applicant stating that
- 19 he has held a hunting license issued by the Commonwealth or

- 1 another state in a prior year but is unable to produce evidence
- 2 <u>of holding such license.</u>
- 3 (b) The commission shall provide for a course of instruction
- 4 in the safe handling of firearms and bows and arrows such as
- 5 approved by the National Rifle Association of America, and for
- 6 this purpose may cooperate with any reputable association or
- 7 organization having as one of its objectives the promotion of
- 8 safety in the handling of firearms, and bows and arrows.
- 9 (c) The commission may designate any person found by it to
- 10 be competent to give instruction in the handling of firearms,
- 11 and bows and arrows [to persons under the age of sixteen years].
- 12 A person so appointed shall give such course of instruction, and
- 13 upon the successful completion thereof shall issue to the person
- 14 instructed a certificate of competency in the safe handling of
- 15 firearms and bows and arrows. No charge shall be made for such
- 16 course of instruction, except for materials or ammunition
- 17 consumed.
- 18 (d) The commission shall furnish information on the
- 19 requirements of the hunter safety education program as provided
- 20 herein, said information to be distributed free of charge to
- 21 applicants for hunting licenses by the persons appointed and
- 22 authorized to issue such licenses.
- 23 Section 2. This act shall take effect in 60 days.
