## AN ACT

- Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An act relating to alcoholic liquors, alcohol and malt and 2 3 brewed beverages; amending, revising, consolidating and 4 changing the laws relating thereto; regulating and restricting the manufacture, purchase, sale, possession, consumption, importation, transportation, furnishing, holding 6 7 in bond, holding in storage, traffic in and use of alcoholic 8 liquors, alcohol and malt and brewed beverages and the persons engaged or employed therein; defining the powers and 9 10 duties of the Pennsylvania Liquor Control Board; providing for the establishment and operation of State liquor stores, 11 12 for the payment of certain license fees to the respective 13 municipalities and townships, for the abatement of certain nuisances and, in certain cases, for search and seizure 14 15 without warrant; prescribing penalties and forfeitures; 16 providing for local option, and repealing existing laws," 17 further providing for special occasion permits and making an 18 editorial change.
- 19 The General Assembly of the Commonwealth of Pennsylvania
- 20 hereby enacts as follows:
- 21 Section 1. Section 408.4, act of April 12, 1951 (P.L.90,
- 22 No.21), known as the "Liquor Code," amended July 11, 1980
- 23 (P.L.558, No.117), is amended to read:
- 24 Section 408.4. Special Occasion Permits. -- (a) Upon
- 25 application of any hospital, church, synagogue, volunteer fire

- 1 company, volunteer ambulance company, volunteer rescue squad,
- 2 bona fide sportsmen's club in existence for at least ten years
- 3 or the women's auxiliary of any of the foregoing and upon
- 4 payment of a fee of fifteen dollars (\$15) per day, the board
- 5 shall issue a special occasion permit good for a period of not
- 6 more than three consecutive days. Special occasion permits may
- 7 also be issued to a museum operated by a nonprofit corporation
- 8 in a city of the third class or a nonprofit corporation engaged
- 9 in the performing arts in a city of the third class for a period
- 10 of not more than six nonconsecutive days at a fee of fifteen
- 11 dollars (\$15) per day.
- 12 (b) In any city, borough, incorporated town or township in
- 13 which the sale of liquor and/or malt or brewed beverages has
- 14 been approved by the electorate, such special occasion permit
- 15 shall authorize the [permittee] hospital, church, synagogue,
- 16 <u>volunteer fire company, volunteer ambulance company, volunteer</u>
- 17 rescue squad, bona fide sportsmen's club in existence for at
- 18 <u>least ten years of the women's auxiliary of any of the foregoing</u>
- 19 to sell liquor and/or malt or brewed beverages as the case may
- 20 be to any adult person on any day for which the permit is
- 21 issued.
- 22 (c) Such special occasion permit shall only be valid for the
- 23 number of days stated in the permit. [Only one] One permit may
- 24 be issued to any [permittee] hospital, church, synagogue,
- 25 <u>volunteer fire company, volunteer ambulance company, volunteer</u>
- 26 rescue squad or bona fide sportsmen's club in existence for at
- 27 least ten years and one permit may be issued to the women's
- 28 <u>auxiliary of any of the foregoing</u> during the year. Provided,
- 29 that a museum operated by a nonprofit corporation in a city of
- 30 the third class and a nonprofit corporation engaged in the

- 1 performing arts in a city of the third class may be issued no
- 2 more than six permits during the year, each permit being valid
- 3 for only one day. [The provisions of this subsection relating to
- 4 the issuance of permits for Bicentennial units shall expire
- 5 December 31, 1976.]
- 6 (d) Such permits shall only be issued for use at a special
- 7 event including, but not limited to bazaars, picnics and
- 8 clambakes. The special event must be one which is used by the
- 9 [permittee] hospital, church, synagogue, volunteer fire company,
- 10 volunteer ambulance company, volunteer rescue squad or bona fide
- 11 sportsmen's club in existence for at least ten years or the
- 12 women's auxiliary of any of the foregoing as a means of raising
- 13 funds for itself.
- 14 (e) The provisions of this section shall not be applicable
- 15 to any licensee now or hereafter possessing a caterer's license,
- 16 nor to any professional fund raiser.
- 17 (f) Any person selling liquor or malt or brewed beverages in
- 18 violation of this section shall, upon summary conviction, be
- 19 sentenced to pay a fine of two hundred fifty dollars (\$250) for
- 20 the first offense and a fine of five hundred dollars (\$500) for
- 21 each subsequent offense. This fine shall be in addition to any
- 22 other penalty imposed by law for the illegal sale of malt or
- 23 brewed beverages.
- 24 Section 2. This act shall take effect in 60 days.
