AN ACT

- 1 Authorizing and directing the Department of General Services,
- with the approval of the Department of Environmental
- 3 Resources and the Governor, to convey to the Catholic Diocese
- 4 of Altoona-Johnstown 1.6952 acres of land situate in Noyes
- 5 Township, Clinton County, Pennsylvania.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. The Department of General Services, with the
- 9 approval of the Department of Environmental Resources and the
- 10 Governor, is hereby authorized and directed on behalf of the
- 11 Commonwealth of Pennsylvania, to grant and convey to the
- 12 Catholic Diocese of Altoona-Johnstown for a consideration of \$1,
- 13 the following tract of land situate in Noyes Township, Clinton
- 14 County, Pennsylvania bounded and described as follows:
- Beginning at a point in the centerline of Township Road 307,
- 16 being the westernmost corner of the lands herein described;
- 17 thence by lands of the Commonwealth of Pennsylvania the
- 18 following three courses in and along the centerline of Township
- 19 Road 307: (1) south 83 degrees 23 minutes 32 seconds east 22.14

- 1 feet to a point; (2) south 87 degrees 45 minutes 29 seconds east
- 2 230.66 feet to a point; and (3) north 89 degrees 08 minutes 12
- 3 seconds east 205.78 feet to a point on the east line of the
- 4 Thomas Willing Warrant 4310; thence along said Warrant line and
- 5 by lands of Berger Alan Anderson south 05 degrees 24 minutes 57
- 6 seconds west 245.00 feet to a point; thence by lands of the
- 7 Commonwealth of Pennsylvania the following two courses: (1)
- 8 north 71 degrees 43 minutes 25 seconds west 380.57 feet to a
- 9 point; and (2) north 29 degrees 00 minutes 00 seconds west
- 10 152.10 feet to a point, the place of beginning.
- 11 Containing 1.6952 acres of land, more or less, and comprising
- 12 a portion of the Thomas Willing Warrant 4310.
- Being a portion of those lands conveyed by Edgar Munson,
- 14 Attorney-in-Fact for the heirs and devisees of Jesse Munson and
- 15 Hiram Merriman to the Commonwealth of Pennsylvania by deed dated
- 16 August 25, 1930 and recorded in Clinton County Deed Book 115,
- 17 Page 518.
- 18 Section 2. The Deed of Conveyance shall be approved in
- 19 accordance with law and shall be executed by the Secretary of
- 20 General Services in the name of the Commonwealth of
- 21 Pennsylvania.
- 22 Section 3. This act shall take effect immediately.
