AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled 2 "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 5 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 7 Teachers Colleges; abolishing, creating, reorganizing or 8 authorizing the reorganization of certain administrative 9 departments, boards, and commissions; defining the powers and 10 duties of the Governor and other executive and administrative officers, and of the several administrative departments, 11 12 boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive 13 and administrative officers; providing for the appointment of 14 15 certain administrative officers, and of all deputies and 16 other assistants and employes in certain departments, boards,

- and commissions; and prescribing the manner in which the
- 2 number and compensation of the deputies and all other
- 3 assistants and employes of certain departments, boards and
- 4 commissions shall be determined, " reserving mineral rights to
- 5 the Commonwealth upon the conveyance of surplus land.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 2405-A, act of April 9, 1929 (P.L.177,
- 9 No.175), known as "The Administrative Code of 1929," added July
- 10 1, 1981 (P.L.143, No.48), is amended by adding a clause to read:
- 11 Section 2405-A.--Conditions Upon Conveyances.--Any proposed
- 12 disposition of property shall be subject to the following
- 13 conditions and limitations:
- 14 * * *
- 15 (6) The deed of conveyance shall expressly reserve all OIL,
- 16 GAS AND mineral rights to the Commonwealth.
- 17 Section 2. This act shall take effect immediately.
