The General Assembly of the Commonwealth of Pennsylvania

- 1 hereby enacts as follows:
- 2 Section 1. Definitions.
- 3 The following words and phrases when used in this act shall
- 4 have, unless the context clearly indicates otherwise, the
- 5 meanings given to them in this section:
- 6 "Agricultural products." Livestock and livestock products
- 7 and poultry products, fruits and fruit products, vegetables and
- 8 vegetable products, grains and hays, timber and timber products
- 9 and the products derived therefrom and other products derived
- 10 from the business of farming, including such other products as
- 11 may be manufactured, derived, or prepared from the heretofore
- 12 mentioned products, raw or processed, which are used as food for
- 13 man or animals.
- 14 "Commission." The Lands Management Commission within the
- 15 Department of Agriculture established by this act.
- 16 "Director." The Land Management Director.
- 17 "Land-use facility." Any processing plant, milking stable,
- 18 institution equipment storage building, barn, silo, grain
- 19 storage building, swinery or any other building owned by an
- 20 agency, department or commission of the Commonwealth used in its
- 21 land-use production and maintenance operations and transferred
- 22 to the commission as provided in this act.
- 23 Section 2. Lands Management Commission.
- 24 There is hereby established within the Department of
- 25 Agriculture a Lands Management Commission composed of nine
- 26 members as follows; the Secretary of Agriculture, who shall be
- 27 chairman, the Secretary of General Services, the Governor or his
- 28 designee, the Director of the Bureau of Rural Affairs of the
- 29 Department of Agriculture, the Chairman of the House Agriculture
- 30 Committee, the Chairman of the Senate Agriculture Committee and

- 1 three farmers appointed from a list of names submitted to the
- 2 Governor by chartered farm organizations. The terms of the
- 3 farmer members shall be for six years. The terms shall be
- 4 staggered and one member shall be appointed every two years. The
- 5 initial appointments of farmer members shall be for terms of
- 6 two, four and six years. No business may be transacted by the
- 7 commission in the absence of a quorum which consists of five
- 8 members. The commission shall annually file a report at the end
- 9 of the fiscal year with the Governor and the members of the
- 10 General Assembly.
- 11 Section 3. Powers and duties of the commission.
- 12 The commission shall manage lands for the most efficient
- 13 production of agricultural products, and provide land and
- 14 facilities for agricultural research and educational purposes.
- 15 The commission shall have full power and authority over all land
- 16 transferred or sold to it, including but not limited to the
- 17 management of; personnel, production, leasing of the land,
- 18 facilities and equipment; the making of recommendations for sale
- 19 with deed restrictions including easements, profits,
- 20 reservations or covenants limiting land use to agriculture; the
- 21 purchase of supplies, facilities and equipment, repairs,
- 22 maintenance, and the sale of agricultural products. Revenue from
- 23 the leasing of land, facilities and equipment and from the sale
- 24 of agricultural products shall be remitted to the State
- 25 Treasurer for payment into a Lands Management Commission Fund as
- 26 provided by section 7. Moneys in the Lands Management Commission
- 27 Fund shall be used by the commission to pay the costs of
- 28 operation, repairs, modernization of facilities and equipment,
- 29 and the purchases of supplies, equipment and facilities.
- 30 Section 4. Land Management Director.

- 1 (a) Appointment.--The secretary, upon approval by the
- 2 commission, shall appoint a Land Management Director. The
- 3 director is responsible for conducting the operation of the
- 4 lands and shall be supervised by the Secretary of Agriculture.
- 5 He shall prepare an annual report of the operations, including a
- 6 list of all receipts and expenditures and shall present it to
- 7 the commission at the end of each fiscal year.
- 8 (b) Duties.--As authorized or directed by the commission,
- 9 the director shall also:
- 10 (1) Prepare the annual budget request for the operation
- of the institutional lands and submit it to the commission
- for approval and submission to the budget office.
- 13 (2) Receive and approve all requisitions for supplies,
- 14 equipment and facilities.
- 15 (3) Recruit assistant managers to supervise each
- 16 operation, if necessary.
- 17 (4) Implement all orders of the commission.
- 18 (5) Supervise all other employees of the commission.
- 19 (6) Transfer supplies, equipment, facilities and
- 20 agricultural products to promote efficiency and improve land
- 21 management.
- 22 (7) Act as commission agent in all negotiations for
- leases, contracts and agreements.
- 24 Section 5. Transfers to commission.
- 25 (a) From the Department of Public Welfare. -- All land whether
- 26 or not presently under leasehold interests, previously
- 27 transferred to the Department of Agriculture from the Department
- 28 of Public Welfare is transferred to the commission. Land shall
- 29 be transferred regardless of current leasehold interests. The
- 30 commission shall administer all leases.

- (b) From other boards, commissions and agencies.--Land,
- 2 together with all easements, mineral rights, appurtenances,
- 3 equipment, agricultural products, inventories, and facilities
- 4 thereon or attached thereto, may be transferred by an agency,
- 5 board or commission to the commission upon its approval. Any
- 6 land so transferred shall be managed by the commission under the
- 7 terms and conditions contained in this act.
- 8 Section 6. Land use division lines.
- 9 (a) Surveys. -- The director shall employ a surveyor to
- 10 establish the division lines and plot plans for lands
- 11 transferred to the commission. In establishing the division
- 12 lines and plot plans, the Land Management Director shall
- 13 cooperate fully with the Department of General Services and any
- 14 other affected Commonwealth agency, department or commission.
- 15 (b) Decisions and disputes. -- In the event of disagreement
- 16 over the placement of a division line, the construction of a
- 17 plot plan or the disposition of equipment, supplies and
- 18 facilities, the Land Management Director and the Commonwealth
- 19 agency, department, or commission involved in the disagreement
- 20 shall, within 30 days, appear before the commission for a
- 21 hearing on the matter. The commission shall decide the matter in
- 22 all cases.
- 23 (c) Utility services and taxes.--The commission shall have
- 24 the power to make agreements with other Commonwealth agencies,
- 25 departments and commissions to provide utility services to lands
- 26 transferred to the commission. The executive director shall
- 27 annually recommend to the board payment in lieu of taxes to
- 28 political subdivisions by the commission.
- 29 Section 7. Administration of funds.
- 30 (a) Lands Management Commission Fund.--All moneys paid into

- 1 the State Treasury under this act shall be paid into a special
- 2 account hereby created and which shall be known as the Lands
- 3 Management Commission Fund.
- 4 (b) Use of fund moneys. --All moneys in the Lands Management
- 5 Commission Fund shall be used to pay:
- 6 (1) The salaries of commission employees.
- 7 (2) Expenses incurred in the administration of this act.
- 8 (3) Expenditures for the purchases of supplies,
- 9 equipment and facilities.
- 10 (c) Transfer of certain funds.--All moneys currently within
- 11 the restricted revenue account known as the Agricultural Farm
- 12 Operations Account of the Bureau of Rural Affairs shall be
- 13 transferred to the Lands Management Commission Fund.
- 14 Section 8. Rules and regulations.
- 15 The commission shall, in the manner provided by law, adopt
- 16 the rules and regulations necessary to carry out this act.
- 17 Section 9. Leases.
- 18 (a) Lease provisions. -- The commission may enter into leases
- 19 for the rental of land, equipment and facilities. Leases shall
- 20 not exceed five years in duration. The commission may grant
- 21 options to renew leases at anytime during the term of lease.
- 22 Options to renew a lease shall not exceed a duration of five
- 23 years.
- 24 (b) Preference. -- The commission shall give preference to
- 25 young farm families who wish to begin a career in agriculture in
- 26 the letting of any lease for land under this act. The commission
- 27 shall set standards, criteria and other qualifications for
- 28 applicants who wish to enter into a lease for land. These
- 29 standards, criteria and qualifications shall be established by
- 30 regulation through the Department of Agriculture.

- Section 10. Appropriation.
- The sum of \$850,000 is hereby appropriated from the General 2

- 3 Fund to the Lands Management Commission Fund to carry out this
- 4 act.
- 5 Section 11 10. Effective date.
- This act shall take effect immediately. 6
