AN ACT

- 1 Authorizing the Township of Independence, Washington County, to
- 2 convey a certain tract of land acquired pursuant to the
- 3 "Project 70 Land Acquisition and Borrowing Act."
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. (a) Pursuant to the requirements of subsection
- 7 (b) of section 20, act of June 22, 1964 (Sp.Sess., P.L.131,
- 8 No.8), known as the "Project 70 Land Acquisition and Borrowing
- 9 Act," the General Assembly hereby authorizes the Department of
- 10 General Services to convey a certain tract of land situated in
- 11 the Township of Independence, Washington County, Pennsylvania to
- 12 Michael D. Klem and Deborah B. Klem, his wife, for and in
- 13 consideration of \$900.
- 14 (b) The land shall be free of restrictions on use and
- 15 alienation prescribed by section 20 of the "Project 70 Land
- 16 Acquisition and Borrowing Act," upon the payment of the \$900
- 17 into the Project 70 Land Acquisition Sinking Fund.
- 18 Section 2. The parcel of land authorized to be transferred

- 1 pursuant to this act to Michael D. Klem and Deborah B. Klem, his
- 2 wife by the Township of Independence, Washington County is more
- 3 particularly described as follows:
- 4 BEGINNING at a concrete monument which is the northwestern
- 5 corner of the tract herein described; thence by land now or
- 6 formerly of Klem South 38 degrees 24 minutes east 620.05 feet to
- 7 a concrete monument; thence by land now or formerly of Southwest
- 8 Coal Company north 48 degrees 10 minutes east 48.88 feet to a
- 9 point in Township Road No. 727; thence along said Township Road
- 10 No. 727 north 27 degrees 25 minutes west 106.29 feet to a point;
- 11 thence along said Township Road No. 727 north 10 degrees 8
- 12 minutes west 63.05 feet to a point; thence along said Township
- 13 Road No. 727 north 6 degrees 6 minutes west 161.63 feet to a
- 14 point; thence by land now or formerly of Independence Township
- 15 Park north 67 degrees 52 minutes west a distance of 368.54 feet
- 16 to the place of beginning.
- 17 Section 3. Costs and fees related to the preparation and
- 18 recordation of documents relating to the conveyance shall be
- 19 paid by the grantee.
- 20 Section 4. The deed of conveyance by the Commonwealth shall
- 21 be approved as provided by law.
- 22 Section 5. This act shall take effect in 60 days.
