A RESOLUTION

- Directing the Insurance Committee to investigate rising health care costs.
- 3 Today 90% of Americans are covered by some form of health
- 4 insurance and of these an estimated 70% are covered by some form
- 5 of group coverage; and
- 6 For the decade of 1965 to 1975, the annual cost for employer
- 7 provided health care benefits increased 350%. In 1965, the
- 8 average cost for an employee per week was \$8. In 1975, the
- 9 average cost for an employee per week was \$28; and
- 10 Not only has group coverage increased but in general, health
- 11 care costs in Pennsylvania have increased at a rate seven times
- 12 the rate of inflation; and
- 13 Why the costs have increased so greatly is of concern to all
- 14 the citizens of Pennsylvania and perhaps legislation can be
- 15 enacted to curtail these rising costs; therefore be it
- 16 RESOLVED, That the House Committee on Insurance be directed
- 17 to investigate all contributing factors bearing on the increase

- 1 in the cost of maintaining the health care delivery system and
- 2 the financing of that system; and be it further
- 3 RESOLVED, That the committee may hold hearings, take
- 4 testimony and make its investigation at such places as it deems
- 5 necessary within this Commonwealth. It may issue subpoenas under
- 6 the hand and seal of its chairman commanding any person to
- 7 appear before it and to answer questions touching matters
- 8 properly being inquired into by the committee and to produce
- 9 such books, papers, records and documents as the committee deems
- 10 necessary. Such subpoenas may be served upon any person and
- 11 shall have the force and effect of subpoenas issued out of the
- 12 courts of this Commonwealth. Any person who willfully neglects
- 13 or refuses to testify before the committee or to produce any
- 14 books, papers, records or documents, shall be subject to the
- 15 penalties provided by the laws of this Commonwealth in such
- 16 case. Each member of the committee shall have the power to
- 17 administer oaths and affirmations to witnesses appearing before
- 18 the committee; and be it further
- 19 RESOLVED, That the committee report its findings to the House
- 20 of Representatives, together with any recommendations, at least
- 21 60 days prior to the end of this session of the General
- 22 Assembly.
