AN ACT

- 1 Amending the act of May 1, 1933 (P.L.103, No.69), entitled "An
- act concerning townships of the second class; and amending,
- 3 revising, consolidating, and changing the law relating
- 4 thereto, "further providing for voting by township
- 5 supervisors.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 511 of the act of May 1, 1933 (P.L.103,
- 9 No.69), known as The Second Class Township Code, reenacted and
- 10 amended July 10, 1947 (P.L.1481, No.567) and amended October 22,
- 11 1981 (P.L.313, No.108), is amended to read:
- 12 Section 511. Organization Meeting; Appointment of Secretary
- 13 and Treasurer. -- The supervisors of each township shall meet, at
- 14 a convenient time and place, on the first Monday in January of
- 15 each year. If the first Monday is a legal holiday, the meeting
- 16 shall be held the first day following. At such time the township
- 17 supervisors shall organize as a board by electing one of their
- 18 number as chairman and another member as vice-chairman. The

- 1 board shall appoint a treasurer and a secretary. The secretary
- 2 shall be an individual, however the board may select either a
- 3 trust company, banking institution or an individual to serve as
- 4 treasurer, or the board may appoint one individual to serve as
- 5 both secretary and treasurer. The secretary-treasurer, secretary
- 6 or treasurer, may or may not be a member of the board. With
- 7 regard to boards of supervisors which are designated as three-
- 8 member boards, any supervisor who is to be considered by such a
- 9 board for secretary-treasurer, secretary or treasurer, shall not
- 10 be excluded from voting on the issue of such appointment; such
- 11 action by a supervisor shall be deemed to be within the scope of
- 12 <u>authority as a supervisor and shall not be deemed to constitute</u>
- 13 <u>an illegal or an improper conflict of interest.</u>
- 14 The meeting under this section may be considered as a regular
- 15 monthly meeting for the transaction of such business as comes
- 16 before it. The first order of business at this meeting shall be
- 17 organization of the board. Any action taken or business
- 18 transacted other than organization of the supervisors as a board
- 19 at any organization meeting held prior to the effective date of
- 20 this amending act, which is invalid for the reason that the
- 21 action was taken or business transacted at an organization
- 22 meeting, is hereby validated and confirmed.
- 23 Section 2. Section 514 of the act, amended July 2, 1953
- 24 (P.L.328, No.72), is amended to read:
- 25 Section 514. Road Districts; Superintendents and
- 26 Roadmasters.--The board of township supervisors, immediately
- 27 after their organization, shall divide the township into one or
- 28 more road districts. They shall employ a superintendent for the
- 29 entire township or a roadmaster for each district. Every
- 30 superintendent and roadmaster, so employed, must be a person

- 1 physically able to work on and maintain the roads. Township
- 2 supervisors may require such superintendents or roadmasters to
- 3 give bond, with a surety company or other company authorized by
- 4 law to act as surety, for the faithful performance of their
- 5 duties. The superintendent or roadmasters shall be subject to
- 6 removal by the board of supervisors. The supervisors shall fix
- 7 the wages to be paid, either per hour, per day, per week, semi-
- 8 monthly or monthly, to the superintendent or roadmasters and
- 9 laborers for work on the roads and bridges, which wages shall
- 10 not exceed wages paid in the locality for similar services.
- 11 This section shall not prohibit the township supervisors from
- 12 being employed as superintendents or roadmasters, or as
- 13 laborers, if physically able to work on and maintain the roads.
- 14 With regard to boards of supervisors which are designated as
- 15 three-member boards, any supervisor who is to be considered by
- 16 <u>such a board for a position as a compensated employe of the</u>
- 17 township, as authorized by this section, shall not be excluded
- 18 from voting on the issue of such appointment; such action by a
- 19 supervisor shall be deemed to be within the scope of authority
- 20 as a supervisor and shall not be deemed to constitute an illegal
- 21 or an improper conflict of interest. In such cases they shall
- 22 not employ a superintendent or roadmasters and their
- 23 compensation shall be fixed as hereinafter provided.
- Two or more townships may appoint the same person as
- 25 superintendent.
- 26 Section 3. This act shall be retroactive to January 1, 1986.
- 27 Section 4. This act shall take effect immediately.
