AN ACT

1 Amending the act of September 30, 1983 (P.L.160, No.39),
 2 entitled "An act establishing salaries and compensation of
 3 certain public officials including justices and judges of
 4 Statewide courts, judges of courts of common pleas, judges of
 5 the Philadelphia Municipal Court, judges of the Philadelphia
 6 Traffic Court, district justices and the Governor, the
 7 Lieutenant Governor, the State Treasurer, the Auditor
 8 General, the Attorney General and certain other State
 9 officers and the salary and certain expenses of the members
 10 of the General Assembly; and repealing certain inconsistent
 11 acts," further providing for the compensation of judges of
 12 the courts of common pleas.

13 The General Assembly of the Commonwealth of Pennsylvania
 14 hereby enacts as follows:

15 Section 1. Section 2(d) of the act of September 30, 1983
 16 (P.L.160, No.39), known as the Public Official Compensation Law,
 17 is amended to read:

18 Section 2. Judiciary.

19 * * *

20 (d) Courts of common pleas.--

21 (1) The annual salary of a president judge of a court of
 22 common pleas shall be fixed in accordance with the following

1 schedule:

2 (i) Allegheny County, [\$67,000] \$72,000.

3 (ii) Philadelphia, [\$67,500] \$72,500.

4 (iii) Judicial districts having six or more judges,
5 [\$66,000] \$71,000.

6 (iv) Judicial districts having three to five judges,
7 [\$65,500] \$70,500.

8 (v) Judicial districts having one or two judges,
9 [\$65,000] \$70,000.

10 (vi) Administrative judges of the divisions of the
11 Court of Common Pleas of Philadelphia County; divisions
12 of six or more judges, [\$66,000] \$71,000.

13 (vii) Administrative judges of the divisions of the
14 Court of Common Pleas of Philadelphia County with
15 divisions of five or less judges, [\$65,500] \$70,500.

16 (viii) Administrative judge of divisions of the
17 Court of Common Pleas of Allegheny County with divisions
18 of six or more judges, [\$66,000] \$71,000.

19 (ix) Administrative judge of divisions of the Court
20 of Common Pleas of Allegheny County of five or less
21 judges, [\$65,500] \$70,500.

22 (2) The other judges of the courts of common pleas shall
23 be paid an annual salary of [\$65,000] \$70,000.

25 Section 2. This act shall take effect in 60 days.
