A RESOLUTION

- 1 Creating a select committee to study the feasibility of the
- 2 establishment of a new law school in the Harrisburg area.
- 3 WHEREAS, There is presently no law school offering an
- 4 evening, part-time course of study within a 75-mile radius of
- 5 Harrisburg; and
- 6 WHEREAS, The establishment of such a law school might be of
- 7 benefit to the government of the Commonwealth and to the
- 8 citizens of this Commonwealth, especially if the law school
- 9 would emphasize a "public law" curriculum; therefore be it
- 10 RESOLVED, That there is created a select committee of the
- 11 House of Representatives, consisting of five members appointed
- 12 by the Majority Leader and four members appointed by the
- 13 Minority Leader, to study the feasibility of the establishment

- 1 of a new law school in the Harrisburg area; and be it further
- 2 RESOLVED, That the select committee utilize existing staff
- 3 and resources of the House of Representatives without further
- 4 appropriation; and be it further
- 5 RESOLVED, That the select committee report its findings to
- 6 the House of Representatives no later than the last session day
- 7 of November 1986.
