- 1 Amending Title 34 (Game) of the Pennsylvania Consolidated
- 2 Statutes, safeguarding the public from attack by exotic
- 3 wildlife.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 2962(c), 2963(c) and 2964(c) of Title 34
- 7 of the Pennsylvania Consolidated Statutes are amended to read:
- 8 § 2962. Exotic wildlife dealer permits.
- 9 * * *
- 10 (c) Unlawful acts.--It is unlawful for any person to:
- 11 (1) Import into this Commonwealth, possess, buy, sell,
- 12 locate or find for a fee, barter, donate, give away or
- 13 otherwise dispose of more than one bird or one animal
- 14 classified as exotic wildlife in any calendar year without
- first securing a permit issued under this section.
- 16 (2) Release exotic wildlife into the wild.
- 17 (3) Fail to exercise due care in safequarding the public
- 18 <u>from attack by exotic wildlife.</u>

- 2 place another person in danger of attack by exotic wildlife.

- 4 § 2963. Exotic wildlife possession permits.

- 6 (c) Unlawful acts.--It is unlawful for any person to:
- 7 (1) Possess, purchase or receive exotic wildlife,
- 8 without first securing a permit to possess exotic wildlife
- 9 issued under this section or regulations pertaining to this
- 10 section.
- 11 (2) Release exotic wildlife into the wild.
- 12 (3) Fail to exercise due care in safequarding the public
- from attack by exotic wildlife.
- 14 (4) Recklessly engage in conduct which places or may
- 15 place another person in danger of attack by exotic wildlife.

- 17 § 2964. Menagerie permits.

- 19 (c) Unlawful acts.--It is unlawful to:
- 20 (1) Keep any wild bird or wild animal in captivity for
- 21 public exhibition, or to have any wild bird or wild animal in
- 22 custody or control for such purpose, without first securing a
- permit issued by the commission.
- 24 (2) Violate any of the provisions of this section or to
- 25 release any bird or animal into the wild.
