AN ACT

1 Amending the act of February 1, 1966 (1965 P.L.1656, No.581),
2 entitled "An act concerning boroughs, and revising, amending
3 and consolidating the law relating to boroughs," providing
4 for limited annual appropriations for support of drug and
5 alcohol abuse programs.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. Section 1202 of the act of February 1, 1966 (1965
9 P.L.1656, No.581), known as The Borough Code, is amended by
10 adding a clause to read:

11 Section 1202. Specific Powers.--The powers of the borough
12 shall be vested in the corporate authorities. Among the specific
13 powers of the borough shall be the following, and in the
14 exercise of any of such powers involving the enactment of any
15 ordinance or the making of any regulation, restriction or
16 prohibition, the borough may provide for the enforcement thereof

1 and may prescribe penalties for the violation thereof or for the
2 failure to conform thereto:

3 * * *

4 (80) Appropriation for support of drug and alcohol abuse
5 programs. To appropriate annually, out of the general funds to
6 the borough, a sum not to exceed five thousand dollars (\$5000)
7 to be divided in such amounts as council deems proper to be used
8 for education and the development of programs within the
9 community dealing with drug and alcohol abuse. Such funds also
10 may be contributed to existing programs available to the
11 borough's residents in adjacent communities or in the county
12 where the borough is situate at the discretion of borough
13 council.

14 Section 2. This act shall take effect in 60 days.
