## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- 2 act relating to the public school system, including certain
- 3 provisions applicable as well to private and parochial
- 4 schools; amending, revising, consolidating and changing the
- 5 laws relating thereto, "increasing reimbursement for school
- 6 building construction; and making editorial changes.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 2574(e) of the act of March 10, 1949
- 10 (P.L.30, No.14), known as the Public School Code of 1949,
- 11 amended June 12, 1968 (P.L.192, No.96), is amended and
- 12 subsections (b) and (c) are amended by adding clauses to read:

- 1 Section 2574. Approved Reimbursable Rental for Leases
- 2 Hereafter Approved and Approved Reimbursable Sinking Fund
- 3 Charges on Indebtedness. -- \* \* \*
- 4 (b) For new school buildings the approved building
- 5 construction cost shall be the lesser of
- 6 \* \* \*
- 7 (4) For school buildings for which the general construction
- 8 contract is awarded subsequent to July 1, 1984, and for approved
- 9 school building projects for which the general construction
- 10 contract was awarded but for which a lease or general obligation
- 11 bond resolution was not approved by the Department of Education
- 12 prior to July 1, 1984, the product of the rated pupil capacity
- 13 <u>as determined by the Department of Education at the time the</u>
- 14 project is approved and (i) five thousand five hundred dollars
- 15 (\$5,500) in the case of elementary schools, (ii) seven thousand
- 16 two hundred dollars (\$7,200) in the case of secondary schools,
- 17 (iii) an amount in the case of combined elementary-secondary
- 18 schools obtained by multiplying the rated elementary pupil
- 19 capacity by five thousand five hundred dollars (\$5,500) and the
- 20 rated secondary pupil capacity by seven thousand two hundred
- 21 <u>dollars (\$7,200)</u> and dividing the sum by the total rated pupil
- 22 capacity.
- 23 (c) For additions or alterations to existing buildings
- 24 approved building construction cost shall be the lesser of
- 25 \* \* \*
- 26 (4) For school buildings for which the general construction
- 27 contract is awarded subsequent to July 1, 1984, and for approved
- 28 school building projects for which the general construction
- 29 contract was awarded but for which a lease or general obligation
- 30 bond resolution was not approved by the Department of Education

- 1 prior to July 1, 1984, the difference obtained by subtracting
- 2 the appraisal value of the existing building from the product of
- 3 the rated pupil capacity of the altered or expanded building as
- 4 determined by the Department of Education at the time the
- 5 project is approved and (i) five thousand five hundred dollars
- 6 (\$5,500) in the case of elementary schools, (ii) seven thousand
- 7 two hundred dollars (\$7,200) in the case of secondary schools,
- 8 (iii) an amount in the case of combined elementary-secondary
- 9 schools obtained by multiplying the rated elementary pupil
- 10 capacity by five thousand five hundred dollars (\$5,500) and the
- 11 rated secondary pupil capacity by seven thousand two hundred
- 12 <u>dollars (\$7,200)</u> and dividing the sum by the total rated pupil
- 13 capacity of the altered or expanded building.
- 14 \* \* \*
- 15 (e) For area vocational-technical school and technical
- 16 institute projects leased subsequent to July 1, 1964, by or for
- 17 lease to a board of school directors authorized to operate such
- 18 a school, the Department of [Public Instruction] Education shall
- 19 calculate an approved reimbursable rental charge.
- 20 For area vocational-technical school and technical institute
- 21 projects constructed or purchased subsequent to July 1, 1964, by
- 22 a board of school directors authorized to operate such a school,
- 23 the Department of [Public Instruction] Education may calculate
- 24 an approved reimbursable sinking fund charge.
- 25 Approved reimbursable rental or sinking fund charge shall
- 26 consist of that part of the annual rental or sinking fund
- 27 attributable to:
- 28 (1) Cost of acquiring land and preparing it for use to the
- 29 extent that such costs are deemed reasonable by the Department
- 30 of [Public Instruction] Education and the interest on such cost

- 1 of acquisition, cost of preparation and the cost of sewage
- 2 treatment and the interest on such costs.
- 3 (2) Machinery, apparatus, furniture and equipment and all
- 4 other necessary expenses and interest charges, but excluding
- 5 architects' fees in excess of six percent of the construction
- 6 cost.
- 7 The approved building construction cost and the interest on
- 8 such construction cost shall not exceed the product of the rated
- 9 full-time pupil capacity, as determined by the Department of
- 10 [Public Instruction] Education at the time the project is
- 11 approved and two thousand two hundred dollars (\$2,200).
- 12 The provisions of the foregoing paragraph shall apply to all
- 13 school building projects for which the general construction
- 14 contract is awarded prior to July 1, 1966, and for approved
- 15 school building projects for which a lease was approved by the
- 16 Department of [Public Instruction] Education prior to July 1,
- 17 1966. For school buildings for which the general construction
- 18 contract is awarded subsequent to July 1, 1966, and for approved
- 19 school building projects for which the general construction
- 20 contract was awarded but for which a lease was not approved by
- 21 the Department of [Public Instruction] Education prior to July
- 22 1, 1966, the approved building construction cost and the
- 23 interest on such construction cost shall not exceed the product
- 24 of the rated full-time pupil capacity, as determined by the
- 25 Department of [Public Instruction] Education at the time the
- 26 project is approved, and three thousand seven hundred dollars
- 27 (\$3700).
- 28 For school buildings for which the general construction
- 29 contract is awarded subsequent to July 1, 1984, and for approved
- 30 school building projects for which the general construction

- 1 contract was awarded but for which a lease or general obligation
- 2 bond resolution was not approved by the Department of Education
- 3 prior to July 1, 1984, the approved building construction cost
- 4 and the interest on such construction cost shall not exceed the
- 5 product of the rated full-time pupil capacity, as determined by
- 6 the Department of Education at the time the project is approved,
- 7 and eight thousand nine hundred dollars (\$8,900).
- 8 The Department of [Public Instruction] Education shall not
- 9 approve the expenditure of any funds borrowed or obtained by the
- 10 sale of bonds by any authority, nonprofit corporation, profit
- 11 corporation, company or individual for construction of area
- 12 vocational-technical schools or technical institutes for
- 13 bleachers, athletic field, lighting equipment or apparatus used
- 14 to promote and conduct interscholastic athletics.

- 16 Section 2. This act shall take effect July 1, 1987.
