AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 4 5 departments, boards, commissions, and officers thereof, 6 including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or 7 8 authorizing the reorganization of certain administrative 9 departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative 10 11 officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the 12 13 Governor, Lieutenant Governor, and certain other executive 14 and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and 15 other assistants and employes in certain departments, boards, 16 17 and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and 18 19 20 commissions shall be determined, "further providing for the 21 definition of "project."
- The General Assembly of the Commonwealth of Pennsylvania
- 23 hereby enacts as follows:
- 24 Section 1. The definition of "project" in section 2801-C of
- 25 the act of April 9, 1929 (P.L.177, No.175), known as The
- 26 Administrative Code of 1929, added December 14, 1982 (P.L.1213,

- 1 No.280), is amended to read:
- 2 Section 2801-C. Definitions.--The following words and
- 3 phrases when used in this article shall have the meanings given
- 4 to them in this section unless the context clearly indicates
- 5 otherwise:
- 6 * * *
- 7 "Project" means an activity, entirely or largely conducted in
- 8 Pennsylvania, which cannot be effectively funded using privately
- 9 available resources, relating to:
- 10 (1) basic and applied research concerning energy use,
- 11 renewable energy resources and energy extraction, transmission,
- 12 storage or conversion;
- 13 (2) limited scale demonstration of innovative or
- 14 commercially unproven technology to promote the production, use
- 15 or conservation of energy; [or]
- 16 (3) activities to promote or remove obstacles to the
- 17 utilization and transportation of Pennsylvania energy resources,
- 18 including but not limited to limited scale synthetic fuel
- 19 facilities and the conversion or technological improvement of
- 20 industrial, commercial or agricultural systems to utilize
- 21 Pennsylvania coal or renewable energy resources: Provided, That
- 22 no such facility unreasonably interferes with private waste
- 23 recycling industries[.];
- 24 (4) activities to promote and develop projects, on a local
- 25 or regional basis, for the cogeneration of power through the
- 26 <u>utilization of solid waste; or</u>
- 27 (5) development and operation of biomass conversion
- 28 <u>facilities for the production of fuel to be further utilized for</u>
- 29 the production of power.
- 30 Section 2. This act shall take effect in 60 days.
