- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain

 - employee of a school district who is convicted of certain

- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 11 as the Public School Code of 1949, is amended by adding a

- 13 Section 527. Drug Law Convictions. -- Any employe,
- 14 professional or otherwise, of a school district, INTERMEDIATE
- 15 UNIT OR AREA VOCATIONAL-TECHNICAL SCHOOL who is convicted of
- 16 delivery of a controlled substance or convicted of possession of

- a controlled substance with the intent to deliver, as prohibited
- 2 by the act of April 14, 1972 (P.L.233, No.64), known as "The
- 3 Controlled Substance, Drug, Device and Cosmetic Act, " shall be
- 4 terminated from his or her employment with the school district. <--
- The board of school directors ENTITY. THE GOVERNING BODY OF THE <-5
- SCHOOL ENTITY shall enforce this section. 6
- Section 2. This act shall take effect in 60 days. 7
