- 23 SECTION 101. SHORT TITLE.
- 24 THIS ACT SHALL BE KNOWN AND MAY BE CITED AS THE SPECIAL AD
- 25 HOC MUNICIPAL POLICE AND FIREFIGHTER POSTRETIREMENT ADJUSTMENT
- 26 ACT.
- 27 SECTION 102. DEFINITIONS.
- THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS ACT SHALL
- 29 HAVE THE MEANINGS GIVEN TO THEM IN THIS SECTION UNLESS THE
- 30 CONTEXT CLEARLY INDICATES OTHERWISE:

- 3 OR MANAGEMENT AFFAIRS OF A MUNICIPAL RETIREMENT SYSTEM, OR THE
- 4 DESIGNEE OF THAT PERSON.
- 5 "FIREFIGHTER." A MUNICIPAL EMPLOYEE WHO HOLDS A FULL-TIME
- 6 POSITION IN THE FIREFIGHTING SERVICE OF A MUNICIPALITY AND HAS
- 7 RETIREMENT COVERAGE PROVIDED BY A RETIREMENT SYSTEM.
- 8 "MUNICIPALITY." A BOROUGH, CITY, COUNTY OF THE SECOND CLASS,
- 9 INCORPORATED TOWN OR TOWNSHIP, HOWEVER CONSTITUTED, WHETHER
- 10 OPERATING UNDER A LEGISLATIVE CHARTER; A MUNICIPAL CODE; AN
- 11 OPTIONAL CHARTER ADOPTED UNDER THE ACT OF JULY 15, 1957
- 12 (P.L.901, NO.399), KNOWN AS THE OPTIONAL THIRD CLASS CITY
- 13 CHARTER LAW; A HOME RULE CHARTER OR AN OPTIONAL PLAN ADOPTED
- 14 UNDER THE ACT OF APRIL 13, 1972 (P.L.184, NO.62), KNOWN AS THE
- 15 HOME RULE CHARTER AND OPTIONAL PLANS LAW; OR OTHER ARRANGEMENT;
- 16 OR AN ASSOCIATION OF THESE MUNICIPALITIES COOPERATING UNDER THE
- 17 ACT OF JULY 12, 1972 (P.L.762, NO.180), REFERRED TO AS THE
- 18 INTERGOVERNMENTAL COOPERATION LAW.
- 19 "POLICE OFFICER." A MUNICIPAL EMPLOYEE WHO HOLDS A FULL-TIME
- 20 POSITION IN THE POLICE SERVICE OF A MUNICIPALITY AND HAS
- 21 RETIREMENT COVERAGE PROVIDED BY A RETIREMENT SYSTEM.
- 22 "POSTRETIREMENT ADJUSTMENT." AN INCREASE IN OR CHANGE IN THE
- 23 AMOUNT OF A RETIREMENT ANNUITY, RETIREMENT BENEFIT, SERVICE
- 24 PENSION OR DISABILITY PENSION BENEFIT GRANTED OR EFFECTIVE AFTER
- 25 ACTIVE EMPLOYMENT CEASES.
- 26 "PUBLIC EMPLOYEE RETIREMENT SYSTEM." AN ENTITY, WHETHER A
- 27 SEPARATE ENTITY OR PART OF A GOVERNMENTAL ENTITY, THAT COLLECTS
- 28 RETIREMENT AND OTHER EMPLOYEE BENEFIT CONTRIBUTIONS FROM
- 29 GOVERNMENT EMPLOYEES AND EMPLOYERS; HOLDS AND MANAGES THE
- 30 RESULTING ASSETS AS RESERVES FOR PRESENT AND FUTURE RETIREMENT

- 1 ANNUITY, RETIREMENT BENEFIT, SERVICE PENSION, OR DISABILITY
- 2 PENSION BENEFIT PAYMENTS; AND MAKES PROVISION FOR THESE PAYMENTS
- 3 TO QUALIFIED RETIREES AND BENEFICIARIES.
- 4 "RETIREMENT SYSTEM." A PUBLIC EMPLOYEE RETIREMENT SYSTEM.
- 5 "SPECIAL AD HOC ADJUSTMENT." A SPECIAL AD HOC MUNICIPAL
- 6 POLICE AND FIREFIGHTER POSTRETIREMENT ADJUSTMENT.
- 7 "SPECIAL AD HOC MUNICIPAL POLICE AND FIREFIGHTER
- 8 POSTRETIREMENT ADJUSTMENT." AN INCREASE IN OR CHANGE IN THE
- 9 AMOUNT OF A RETIREMENT ANNUITY, RETIREMENT BENEFIT, SERVICE

- 16 SECTION 301. ENTITLEMENT TO SPECIAL AD HOC ADJUSTMENT.
- A MUNICIPAL RETIREMENT SYSTEM SHALL PAY A RETIRED POLICE
- 18 OFFICER OR FIREFIGHTER A SPECIAL AD HOC MUNICIPAL POLICE AND
- 19 FIREFIGHTER POSTRETIREMENT ADJUSTMENT UNDER THIS CHAPTER IF ALL
- 20 OF THE FOLLOWING APPLY:
- 21 (1) THE RETIREE HAS TERMINATED ACTIVE EMPLOYMENT WITH
- 22 THE MUNICIPALITY AS A POLICE OFFICER OR FIREFIGHTER.
- 23 (2) THE RETIREE IS RECEIVING A RETIREMENT ANNUITY,
- 24 RETIREMENT BENEFIT, SERVICE PENSION OR DISABILITY PENSION
- 25 BENEFIT FROM A MUNICIPAL RETIREMENT SYSTEM ON THE BASIS OF
- 26 ACTIVE EMPLOYMENT WITH A MUNICIPALITY AS A POLICE OFFICER OR
- FIREFIGHTER.
- 28 (3) THE RETIREE BEGAN RECEIVING THE RETIREMENT ANNUITY,
- 29 RETIREMENT BENEFIT, SERVICE PENSION OR DISABILITY PENSION
- 30 BENEFIT BEFORE JANUARY 1, 1985.

- 1 SECTION 302. AMOUNT OF SPECIAL AD HOC ADJUSTMENT.
- 2 (A) GENERAL RULE. -- EXCEPT AS PROVIDED IN SUBSECTIONS (B) AND
- 3 (C), A MUNICIPAL RETIREMENT SYSTEM SHALL PAY A RETIRED POLICE
- 4 OFFICER OR FIREFIGHTER A SPECIAL AD HOC MUNICIPAL POLICE AND
- 5 FIREFIGHTER POSTRETIREMENT ADJUSTMENT UNDER SECTION 301, AS
- 6 FOLLOWS:

- 17 RETIREE HAS BEEN RETIRED AT LEAST 20 YEARS.
- 18 (B) LIMITATION.--IF, UNDER SECTION 301, A RETIREE IS
- 19 ENTITLED TO BE PAID A SPECIAL AD HOC MUNICIPAL POLICE AND
- 20 FIREFIGHTER POSTRETIREMENT ADJUSTMENT BY MORE THAN ONE MUNICIPAL
- 21 RETIREMENT SYSTEM, THE AMOUNT OF THE SPECIAL AD HOC ADJUSTMENT

- 29 SECTION 502. REIMBURSEMENT BY COMMONWEALTH.
- 30 (A) GENERAL RULE. -- EXCEPT AS PROVIDED IN SUBSECTION (B), IN

- 1 EACH OF THE TEN CALENDAR YEARS BEGINNING JANUARY 1, 1990, THE
- 2 COMMONWEALTH SHALL REIMBURSE A MUNICIPALITY, FROM THE SPECIAL
- 3 ACCOUNT ESTABLISHED UNDER SECTION 701, FOR THE ACTUAL SPECIAL AD
- 4 HOC ADJUSTMENT PAID DURING THE PREVIOUS CALENDAR YEAR.
- 5 (B) LIMITATION. -- THE COMMONWEALTH SHALL NOT REIMBURSE ANY
- 6 MUNICIPALITY FOR WHICH ANY ONE OF THE FOLLOWING APPLY:

- 10 PENSION SYSTEMS TO HAVE AN ACTUARIAL INVESTIGATION OF THE
- 11 FUND MADE BY AN ACTUARY WHO SHALL REPORT HIS FINDINGS TO THE
- 12 DEPARTMENT OF COMMUNITY AFFAIRS, " OR THE ACT OF DECEMBER 18,
- 13 1984 (P.L.1005, NO.205), KNOWN AS THE MUNICIPAL PENSION PLAN
- 14 FUNDING STANDARD AND RECOVERY ACT, SHOWS ASSETS IN EXCESS OF
- 15 THE PRESENT VALUE OF FUTURE BENEFITS.
- 16 (2) THE INFORMATION REQUIRED UNDER SECTION 901 EITHER
- 17 WAS NOT CERTIFIED TO THE AUDITOR GENERAL OR WAS CERTIFIED
- 18 AFTER APRIL 1 OF THE YEAR THE CERTIFICATION WAS DUE.

- 14 SECTION 1103. EFFECTIVE DATE.
- 15 THIS ACT SHALL TAKE EFFECT IN 60 DAYS.
