## AN ACT

- 1 Amending Title 24 (Education) of the Pennsylvania Consolidated
- 2 Statutes, further providing for creditable nonschool service.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Section 8304(b) of Title 24 of the Pennsylvania
- 6 Consolidated Statutes, amended October 21, 1988 (P.L.844,
- 7 No.112), is amended to read:
- 8 § 8304. Creditable nonschool service.
- 9 \* \* \*
- 10 (b) Limitations on nonschool service. -- Creditable nonschool
- 11 service credit shall be limited to:
- 12 (1) Intervening military service.
- 13 (2) Other military service not exceeding five years.
- 14 (3) Service in any public school or public educational
- institution in any state other than this Commonwealth or in
- 16 any territory or area under the jurisdiction of the United
- 17 States. This paragraph includes service, prior to July 1,

- 1 1965, at a community college established under the act of
- 2 August 24, 1963 (P.L.1132, No.484), known as the Community
- 3 College Act of 1963.
- 4 (4) Service as an administrator, teacher, or instructor
- 5 in the field of public school education for any agency or
- 6 department of the government of the United States whether or
- 7 not such area was under the jurisdiction of the United
- 8 States.
- 9 (5) Previous service as an employee of a county board of
- 10 school directors which employment was terminated because of
- 11 the transfer of the administration of such service or of the
- 12 entire agency to a governmental entity.
- 13 (6) Previous service as a county employee as a nurse.
- 14 For every three years or major fraction thereof in previous
- work experience, an individual may buy one year of creditable
- service, not to exceed a total of five years. The purchase of
- this service shall begin within three years of the employee's
- 18 eligibility to purchase this creditable service.
- 19 (7) Previous work experience of the type required for
- 20 permanent certification as a vocational teacher. For every
- 21 three years or major fraction thereof, an individual can buy
- one year of creditable service, not to exceed a total of five
- 23 years. Previous work experience shall not include time served
- in an apprenticeship. The purchase of this service shall
- 25 <u>begin within three years of the employee's eligibility to</u>
- 26 <u>purchase this cred</u>itable service.

- 29 § 8324. Contributions for purchase of credit for creditable
- 30 nonschool service.

- 2 (e) Creditable work experience. Contributions on account of <-
- 3 T C credit for creditable work experience pursuant to section
- 4 8304(b)(6) and (7) shall be the present value of the full
- 5 actuarial cost of the increase in the projected superannuation
- 6 annuity caused by the additional service credited on account of
- 7 the purchase of creditable work experience. The amount paid for
- 8 the purchase of credit for creditable work experience under
- 9 <u>section 8304(b)(6) and (7)</u> shall not be payable as a lump sum
- 10 under section 8345(a)(4)(iii) (relating to member's options).
- 11 Any individual eligible to receive an annuity, excluding an
- 12 annuity received under the Federal Social Security Act (42
- 13 U.S.C. § 301 et seq.), in another pension system, other than a
- 14 military pension system, shall not be eligible to purchase this

- 16 (E) CREDITABLE WORK EXPERIENCE.--
- 17 (1) CONTRIBUTIONS ON ACCOUNT OF T-C CREDIT FOR
- 18 CREDITABLE WORK EXPERIENCE PURSUANT TO SECTION 8304(B)(6)
- 19 SHALL BE THE PRESENT VALUE OF THE FULL ACTUARIAL COST OF THE
- 20 INCREASE IN THE PROJECTED SUPERANNUATION ANNUITY CAUSED BY
- 21 THE ADDITIONAL SERVICE CREDITED ON ACCOUNT OF THE PURCHASE OF
- 22 CREDITABLE WORK EXPERIENCE. [THE AMOUNT PAID FOR THE PURCHASE
- 23 OF CREDIT FOR CREDITABLE WORK EXPERIENCE SHALL NOT BE PAYABLE
- 24 AS A LUMP SUM UNDER SECTION 8345(A)(4)(III) (RELATING TO
- 25 MEMBER'S OPTIONS).] ANY INDIVIDUAL ELIGIBLE TO RECEIVE AN
- 26 ANNUITY, EXCLUDING AN ANNUITY RECEIVED UNDER THE FEDERAL
- 27 SOCIAL SECURITY ACT (42 U.S.C. § 301 ET SEQ.), IN ANOTHER
- 28 PENSION SYSTEM, OTHER THAN A MILITARY PENSION SYSTEM, SHALL
- 29 NOT BE ELIGIBLE TO PURCHASE THIS SERVICE.
- 30 (2) CONTRIBUTIONS ON ACCOUNT OF T-C CREDIT FOR

1 CREDITABLE WORK EXPERIENCE PURSUANT TO SECTION 8304(B)(7) 2 SHALL BE THE INCREASE IN THE PRESENT VALUE AT THE TIME OF 3 PURCHASE ATTRIBUTABLE TO THE ADDITIONAL SERVICE CREDITED ON 4 ACCOUNT OF THE PURCHASE OF SUCH CREDITABLE WORK EXPERIENCE, 5 CALCULATED ON THE BASIS OF THE AVERAGE ANNUAL COMPENSATION 6 RECEIVED DURING THE FIRST THREE YEARS OF CREDITED SCHOOL 7 SERVICE SUBSEQUENT TO SUCH CREDITABLE WORK EXPERIENCE. (3) THE AMOUNT PAID FOR THE PURCHASE OF SERVICE UNDER 8 9 THIS SUBSECTION SHALL NOT BE PAYABLE AS A LUMP SUM UNDER 10 SECTION 8345(A)(4)(III) (RELATING TO MEMBER'S OPTIONS). 11 Section 3. This act shall take effect in 60 days.
