AN ACT

1 Amending the act of July 1, 1981 (P.L.191, No.57), entitled "An
2 act establishing certain fees to be charged by registers of
3 wills in counties of the fifth, sixth, seventh and eighth
4 class and providing for fees in counties of the second,
5 second A, third and fourth class," ~~fixing~~ PROVIDING FOR the
6 fees to be levied by register of wills in counties of the
7 second through fourth class. <—

8 The General Assembly of the Commonwealth of Pennsylvania
9 hereby enacts as follows:

10 Section 1. Section 2 of the act of July 1, 1981 (P.L.191,
11 No.57), entitled "An act establishing certain fees to be charged
12 by registers of wills in counties of the fifth, sixth, seventh
13 and eighth class and providing for fees in counties of the
14 second, second A, third and fourth class," is ~~amended to read:~~
15 REPEALED.

16 Section 2. In counties of the second, second A, third and
17 fourth class [all existing fees and charges collected by the
18 register of wills shall continue in effect and shall not be
19 increased except by an act of the Legislature.] the following

SECTION 2.1. IN COUNTIES OF THE SECOND, SECOND A, THIRD AND

7 FOURTH CLASS, THE REGISTER OF WILLS MAY ESTABLISH, INCREASE,

8 DECREASE, MODIFY OR ELIMINATE FEES AND CHARGES WITH THE APPROVAL

9 OF THE PRESIDENT JUDGE WITHIN 60 DAYS OF THE EFFECTIVE DATE OF

10 THIS SECTION. THEREAFTER, SUCH FEES AND CHARGES SHALL NOT BE

11 ESTABLISHED, INCREASED, DECREASED, MODIFIED OR ELIMINATED EXCEPT

12 BY AN ACT OF THE GENERAL ASSEMBLY.
