AN ACT

- Amending the act of April 12, 1951 (P.L.90, No.21), entitled, as 2 reenacted, "An act relating to alcoholic liquors, alcohol and 3 malt and brewed beverages; amending, revising, consolidating and changing the laws relating thereto; regulating and 5 restricting the manufacture, purchase, sale, possession, 6 consumption, importation, transportation, furnishing, holding 7 in bond, holding in storage, traffic in and use of alcoholic 8 liquors, alcohol and malt and brewed beverages and the 9 persons engaged or employed therein; defining the powers and 10 duties of the Pennsylvania Liquor Control Board; providing 11 for the establishment and operation of State liquor stores, 12 for the payment of certain license fees to the respective municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 15 without warrant; prescribing penalties and forfeitures; providing for local option, and repealing existing laws," 16 17 further providing for the powers and duties of the enforcement officers. 18
- 19 The General Assembly of the Commonwealth of Pennsylvania
- 20 hereby enacts as follows:
- 21 Section 1. Section 211 of the act of April 12, 1951 (P.L.90,
- 22 No.21), known as the Liquor Code, reenacted and amended June 29,
- 23 1987 (P.L.32, No.14), is amended to read:
- 24 Section 211. Enforcement. -- (a) There is created within the
- 25 Pennsylvania State Police a Bureau of Liquor Control Enforcement

- 1 which shall be responsible for enforcing this act and any
- 2 regulations promulgated pursuant thereto. Officers and
- 3 investigators assigned to the bureau shall have the power and
- 4 their duty shall be:
- 5 (1) To investigate whenever there are reasonable grounds to
- 6 believe liquor, alcohol or malt or brewed beverages are being
- 7 sold on premises not licensed under the provisions of this act.
- 8 If the investigation produces evidence of the unlawful sale of
- 9 liquor or malt or brewed beverages or any other violation of the
- 10 provisions of this act, the officer involved in the
- 11 investigation shall institute criminal proceedings against the
- 12 person or persons believed to have been criminally liable, as
- 13 otherwise provided by law or rule of court.
- 14 (2) To arrest on view, except in private homes, without
- 15 warrant, any person actually engaged in the unlawful sale,
- 16 importation, manufacture or transportation or having unlawful
- 17 possession of liquor, alcohol or malt or brewed beverages
- 18 contrary to the provisions of this act or any other law of this
- 19 Commonwealth or any person within a licensed premises who is
- 20 violating the act of April 14, 1972 (P.L.233, No.64), known as
- 21 "The Controlled Substance, Drug, Device and Cosmetic Act."
- 22 (3) Upon reasonable and probable cause, to search for and to
- 23 seize, without warrant or process, except in private homes, any
- 24 liquor, alcohol or malt or brewed beverages unlawfully
- 25 possessed, manufactured, sold, imported or transported and any
- 26 stills, equipment, materials, utensils, vehicles, boats,
- 27 vessels, animals, aircraft, or any of them, which are or have
- 28 been used in the unlawful manufacture, sale, importation or
- 29 transportation of the same. Such liquor, alcohol, malt or brewed
- 30 beverages, stills, equipment, materials, utensils, vehicles,

- 1 boats, vessels, animals or aircraft so seized shall be disposed
- 2 of as hereinafter provided.
- 3 (4) To investigate and issue citations for any violations of
- 4 this act or any laws of this Commonwealth relating to liquor,
- 5 alcohol or malt or brewed beverages, or any regulations of the
- 6 board adopted pursuant to such laws or any violation of any laws
- 7 of this Commonwealth or of the Federal Government, relating to
- 8 the payment of taxes on liquor, alcohol or malt or brewed
- 9 beverages by any licensee, his officers, servants, agents or
- 10 employes.
- 11 (5) To confiscate the license of any licensee where any
- 12 <u>officer or investigator arrests the licensee or his agent for</u>
- 13 any violation of "The Controlled Substance, Drug, Device and
- 14 Cosmetic Act," within the licensed premises. The licensed
- 15 <u>establishment shall be closed and padlocked by the enforcement</u>
- 16 <u>officer or investigator until the licensee or his agent is</u>
- 17 convicted or acquitted of the charges, or the charges are
- 18 otherwise disposed.
- 19 (b) Any equipment or appurtenance actually used in the
- 20 commission of the unlawful acts may be confiscated. The
- 21 confiscation shall not, in any manner, divest or impair the
- 22 rights or interest of any bona fide lienholder in the equipment
- 23 or appurtenance.
- 24 (c) The Pennsylvania State Police Commissioner shall assign
- 25 State Police Officers to such supervisory and other capacities
- 26 in the enforcement bureau as he deems necessary. All other
- 27 personnel of the enforcement bureau shall be civilians.
- 28 (d) The Office of Chief Counsel for the Pennsylvania State
- 29 Police shall represent the enforcement bureau in all enforcement
- 30 proceedings brought before the Office of Administrative Law

- 1 Judge or any other adjudicatory body.
- 2 Section 2. This act shall take effect immediately.
