3 Section 507. Amount of Pension. -- Except as provided for 4 payment for nursing home care, the amount paid after the 5 effective date of this act to an eligible blind person having actual annual income of his own of [three thousand sixty dollars 6 7 (\$3,060)] five thousand eighty-six dollars (\$5,086) or less 8 shall be one hundred dollars (\$100) monthly, and the monthly 9 amount paid to any other eligible blind person shall be fixed in such amount that the sum of his actual annual income and State 10 blind pension equals [four thousand two hundred sixty dollars 11 12 (\$4,260)] six thousand two hundred eighty-six dollars (\$6,286) a 13 year.

14 Section 2. This act shall take effect July 1, 1990.
