AN ACT

- 1 Providing for certain debt reports to be submitted by cities of 2 the first class to the Department of Community Affairs.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the First Class
- 7 City Debt Reporting Law.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Borrowing base." The annual arithmetic average of the total
- 13 revenues for the three full fiscal years ended next preceding
- 14 the date of the incurring of nonelectoral debt or lease rental
- 15 debt as set forth in a certificate stating the total revenues in
- 16 each of such years and stating such average, executed by the
- 17 authorized officials of the city or by an independent

- 1 accountant. If, within the three-year period, there has been an
- 2 expansion or contraction of the territorial or functional
- 3 jurisdiction of the city through transfer, merger, annexation or
- 4 assumption, in whole or in part, in relation to another local
- 5 government unit or an authority, the borrowing base shall be
- 6 calculated as if the expansion or contraction had occurred
- 7 within or prior to the commencement of the three-year period in
- 8 such manner as the statutes, charter provisions or court decree
- 9 shall provide or direct or, in the absence of such provisions,
- 10 as the department shall approve.
- 11 "City." A city of the first class.
- 12 "Department." The Department of Community Affairs of the
- 13 Commonwealth.
- 14 "School district." A school district of the first class.
- 15 Section 3. Annual debt report.
- On or before March 15 of every year, the director of finance
- 17 for the city shall submit to the department an annual debt
- 18 report for the previous calendar year that includes the
- 19 following information:
- 20 (1) Gross indebtedness of the city, including any debt
- 21 incurred by or for the school district and any municipal
- 22 authority created by the city. The indebtedness of the school
- 23 district and any municipal authority created by the city
- shall be listed separately.
- 25 (2) A list of each outstanding bond with its purpose,
- the interest rate and repayment schedule for each bond and
- 27 the extent to which each bond is self-liquidating or
- 28 subsidized.
- 29 (3) The borrowing base for the city.
- 30 (4) The debt limit of the city according to section 12

- of Article IX of the Constitution of Pennsylvania.
- 2 (5) A projection of debt requirements for the following
- 3 two calendar years.
- 4 Section 4. Independent evaluation.
- 5 The department shall evaluate or arrange to have outside
- 6 experts evaluate the city's debt situation and, if applicable,
- 7 make recommendations that might improve the city's debt rating
- 8 and financial condition.
- 9 Section 5. First report.
- 10 The first debt statement shall be submitted to the department
- 11 on or before March 15, 1991.
- 12 Section 6. Effective date.
- 13 This act shall take effect immediately.
