## AN ACT

- 1 Providing for health insurance coverage of children; and
- 2 conferring powers and duties on the Department of Health and
- 3 the Insurance Department.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Childhood
- 8 Immunization Insurance Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the

- 1 context clearly indicates otherwise:
- 2 "Child immunizations." Immunizations, including the
- 3 immunizing agent, reimbursement for which shall not exceed 150%
- 4 of the average wholesale price, which, as determined by the
- 5 Department of Health, conform with the standards of the Advisory
- 6 Committee on Immunization Practices of the Center for Disease
- 7 Control, the United States Department of Health and Human
- 8 Services.
- 9 "Health insurance policy." Any EXCEPT FOR SPECIFIED DISEASE <--
- 10 POLICIES, SHALL MEAN ANY GROUP health insurance policy, contract
- 11 or plan, whether individual or group, OR ANY INDIVIDUAL POLICY, <-
- 12 CONTRACT OR PLAN WITH DEPENDENT COVERAGE FOR CHILDREN, which
- 13 provides medical coverage on an expense incurred, service or
- 14 prepaid basis. The term includes the following:
- 15 (1) A health insurance policy or contract issued by a
- nonprofit corporation subject to 40 Pa.C.S. Chs. 61 (relating
- to hospital plan corporations), 63 (relating to professional
- 18 health services plan corporations) and 65 (relating to
- 19 fraternal benefit societies).
- 20 (2) A health service plan operating under the act of
- 21 December 29, 1972 (P.L.1701, No.364), known as the Health
- 22 Maintenance Organization Act.
- 23 (3) An employee welfare benefit plan as defined in
- 24 section 3 of the Employee Retirement Income Security Act of
- 25 1974 (Public Law 93-406, 88 Stat. 829).
- 26 Section 3. Child immunizations.
- 27 Any EXCEPT AS PROVIDED IN SECTION 6, ANY health insurance
- 28 policy which is delivered, issued for delivery, renewed,
- 29 extended or modified in this Commonwealth by any health care
- 30 insurer shall provide that the health insurance benefits

- 1 applicable under the policy include coverage for child
- 2 immunizations. A health insurance policy shall provide for
- 3 coverage for medically necessary booster doses of all immunizing
- 4 agents used in child immunizations.
- 5 Section 4. Delivery of policy.
- 6 If EXCEPT AS PROVIDED IN SECTION 6, IF a health insurance
- 7 policy provides coverage or benefits to a resident of this
- 8 Commonwealth, it shall be deemed to be delivered in this
- 9 Commonwealth within the meaning of this act, regardless of
- 10 whether the health care insurer issuing or delivering said
- 11 policy is located within or outside this Commonwealth.
- 12 Section 5. Cost-sharing provisions.
- 13 (a) Applicability.--Benefits for child immunization services
- 14 shall be subject to copayment and coinsurance provisions of a
- 15 health insurance policy to the extent that other medical
- 16 services covered by the policy are subject to those provisions.
- 17 (b) Exemption.--Benefits for child immunization services
- 18 shall be exempt from deductible or dollar limit provisions in a
- 19 health insurance policy. This exemption must be explicitly
- 20 provided for in the policy.
- 21 SECTION 6. EXEMPTION.
- 22 NOTWITHSTANDING SECTIONS 3 AND 4, THIS ACT SHALL NOT BE
- 23 CONSTRUED TO REQUIRE A HEALTH INSURANCE POLICY TO INCLUDE
- 24 COVERAGE FOR CHILD IMMUNIZATIONS FOR AN INDIVIDUAL WHO IS A
- 25 RESIDENT OF THIS COMMONWEALTH IF ALL OF THE FOLLOWING APPLY:
- 26 (1) THE INDIVIDUAL'S EMPLOYER IS LOCATED OUTSIDE THIS
- 27 COMMONWEALTH.
- 28 (2) THE INDIVIDUAL'S EMPLOYER MAINTAINS A HEALTH
- 29 INSURANCE POLICY FOR THE INDIVIDUAL AS AN EMPLOYMENT BENEFIT.
- 30 Section 6 7. Regulations.

- 1 The Department of Health and the Insurance Department shall
- 2 promulgate regulations to implement this act.
- 3 Section 7 8. Application of act.
- 4 This act shall apply to all insurance policies, subscriber

- 5 contracts and group insurance certificates issued under any
- 6 group master policy, delivered or issued for delivery on or
- 7 after the effective date of this act. This act shall also apply
- 8 to all renewals of contracts on any renewal date which is on or
- 9 after the effective date of this act.
- 10 Section 8 9. Effective date.
- 11 This act shall take effect in six months.
