AN ACT

Amending the act of June 18, 1974 (P.L.359, No.120), entitled "An act creating the Municipal Police Officers' Education and 3 Training Commission; providing for the commission's 4 membership, selection, compensation, and removal; providing for the powers and duties of the commission; providing for the appointment and duties of the chairman; providing for the 6 7 act's applicability to the civil service laws; requiring 8 training by certain political subdivisions and police departments; providing penalties for violation thereof; and 9 making an appropriation, " providing for training of police 10 officers hired by first class city housing authorities; and 11 12 making a repeal. 13 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 15 Section 1. Section 2(6) of the act of June 18, 1974 (P.L.359, No.120), referred to as the Municipal Police Education 16 17 and Training Law, amended December 20, 1984 (P.L.1197, No.227), 18 is amended to read: Section 2. Definitions. -- As used in this act: 19 20 21 (6) "Political subdivision" means any county, city, borough, 22 incorporated town [or township], township or a first class city

- 3 Section 2. This act shall be applicable to all police
- 4 officers hired by first class city housing authorities on and
- 5 after the date one year prior to the effective date of this
- 6 amendatory act, and these officers shall have one year after the
- 7 effective date of this amendatory act in which to comply with
- 8 its provisions. All police officers hired prior to such date
- 9 shall be exempt from the requirements of this act.
- 10 Section 3. Section 2 of the act of October 5, 1980 (P.L.692,
- 11 No.141), entitled "An act amending the act of June 18, 1974
- 12 (P.L.359, No.120), entitled 'An act creating the Municipal
- 13 Police Officers' Education and Training Commission; providing
- 14 for the commission's membership, selection, compensation, and
- 15 removal; providing for the powers and duties of the commission;
- 16 providing for the appointment and duties of the chairman;
- 17 providing for the act's applicability to the civil service laws;
- 18 requiring training by certain political subdivisions and police
- 19 departments; providing penalties for violation thereof; and
- 20 making an appropriation, 'providing police training for security
- 21 officers appointed by first class city housing authorities," is
- 22 hereby repealed.
- 23 Section 4. This act shall take effect in 60 days.
