AN ACT

- 1 Amending the act of May 23, 1945 (P.L.903, No.362), entitled "An
- 2 act authorizing cities of the third class to establish an
- 3 optional retirement system for officers and employes
- 4 independently of any pension system or systems existing in
- 5 such cities," further providing for membership on retirement
- 6 boards; and authorizing cost-of-living increases.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 3 of the act of May 23, 1945 (P.L.903,
- 10 No.362), entitled "An act authorizing cities of the third class
- 11 to establish an optional retirement system for officers and
- 12 employes independently of any pension system or systems existing
- 13 in such cities, " amended July 18, 1986 (P.L.1413, No.128), is
- 14 amended to read:
- 15 Section 3. In any such city which creates such retirement
- 16 system there shall be created a board to be known as the
- 17 "Officers and Employes Retirement Board," consisting of the

- 1 mayor, the city controller, the director of finance, two
- 2 employes to be chosen by the employes contributing to the
- 3 retirement fund, subject to the condition that if, on or after
- 4 September 1, 1991, a vacancy occurs among the employe members of
- 5 the board, a retired city employe chosen by the association of
- 6 retired city employes shall be appointed to the board and a
- 7 retired city employe shall thereafter hold membership on the
- 8 board and, if members of council participate in the retirement
- 9 fund and are members of the fund, a member of council, chosen by
- 10 council. It shall be the duty of said board to register all
- 11 persons employed by the said city, and to administer the
- 12 collections and distribution of the fund, herein provided for,
- 13 and make such reasonable rules in the premises as such board may
- 14 deem necessary to carry into effect the provisions of this act.
- 15 Section 2. The act is amended by adding a section to read:
- 16 Section 4.1. (a) The board may, subject to the approval
- 17 required under subsection (b), increase the compensation of any
- 18 member of the fund by reason of and after the termination of the
- 19 services of such member of the fund. Such increases shall be in
- 20 conformity with a uniform scale, which shall be based on the
- 21 Consumer Price Index for all urban consumers calculated by the
- 22 Bureau of Labor Statistics of the United States Department of
- 23 Labor, but the total of any such allowance shall not at any time
- 24 <u>exceed one-half of the current salary being paid to nonuniformed</u>

- 25 employes of the highest pay grade. No cost of living increase
- 26 <u>shall be granted which would impair the actuarial soundness of</u>
- 27 the fund.
- 28 (b) The board may recommend the increase described in
- 29 <u>subsection (a) to the city council at any time. Provided that</u>
- 30 the provisions of section 305 of the act of December 18, 1984

- 1 (P.L.1005, No.205), known as the "Municipal Pension Plan Funding
- 2 Standard and Recovery Act, " have been satisfied, the council, by
- 3 ordinance, may approve this increase subject, however, to the
- 4 approval of the mayor.
- 5 Section 3. This act shall take effect in 60 days.
