AN ACT

- Amending the act of July 31, 1968 (P.L.805, No.247), entitled, as reenacted and amended, "An act to empower cities of the second class A, and third class, boroughs, incorporated 2 3 towns, townships of the first and second classes including those within a county of the second class and counties of the 6 second class A through eighth classes, individually or 7 jointly, to plan their development and to govern the same by 8 zoning, subdivision and land development ordinances, planned 9 residential development and other ordinances, by official maps, by the reservation of certain land for future public 10 purpose and by the acquisition of such land; to promote the 11 12 conservation of energy through the use of planning practices 13 and to promote the effective utilization of renewable energy 14 sources; providing for the establishment of planning 15 commissions, planning departments, planning committees and 16 zoning hearing boards, authorizing them to charge fees, make 17 inspections and hold public hearings; providing for 18 mediation; providing for transferable development rights; 19 providing for appropriations, appeals to courts and penalties 20 for violations; and repealing acts and parts of acts," 21 providing for the uniformity of water rates.
- 22 The General Assembly of the Commonwealth of Pennsylvania
- 23 hereby enacts as follows:
- 24 Section 1. The act of July 31, 1968 (P.L.805, No.247), known
- 25 as the Pennsylvania Municipalities Planning Code, reenacted and
- 26 amended December 21, 1988 (P.L.1329, No.170), is amended by
- 27 adding a section to read:

- 1 Section 508-A. Uniform Assessment of Water Fees.--No
- 2 <u>municipality may establish or maintain water rates charged for</u>
- 3 providing service to residential buildings within the area
- 4 served by its facilities unless the rates are reasonable and
- 5 uniform in accordance with the applicable provisions of the act
- 6 of May 2, 1945 (P.L.382, No.164), known as the "Municipality
- 7 Authorities Act of 1945."
- 8 Section 2. The following acts and parts of acts are repealed
- 9 insofar as they are inconsistent with this act:
- 10 Act of June 23, 1931 (P.L.932, No.317), known as The Third
- 11 Class City Code.
- 12 Act of June 24, 1931 (P.L.1206, No.331), known as The First
- 13 Class Township Code.
- 14 Act of May 1, 1933 (P.L.103, No.69), known as The Second
- 15 Class Township Code.
- 16 Act of August 9, 1955 (P.L.323, No.130), known as The County
- 17 Code.
- 18 Act of July 18, 1957 (P.L.1006, No.446), entitled "A
- 19 supplement to the act of May 2, 1945 (P.L.382, No.164), entitled
- 20 'An act providing for the incorporation as bodies corporate and
- 21 politic of 'Authorities' for municipalities, counties and
- 22 townships; prescribing the rights, powers and duties of such
- 23 Authorities heretofore or hereafter incorporated; authorizing
- 24 such Authorities to acquire, construct, improve, maintain and
- 25 operate projects, and to borrow money and issue bonds therefor;
- 26 providing for the payment of such bonds, and prescribing the
- 27 rights of the holders thereof; conferring the right of eminent
- 28 domain on such Authorities; authorizing such Authorities to
- 29 enter into contracts with and to accept grants from the Federal
- 30 Government or any agency thereof; and conferring exclusive

- 1 jurisdiction on certain courts over rates,' granting certain
- 2 powers to Authorities organized by a county or counties and
- 3 engaged solely in the construction or acquisition and operation
- 4 of water works, water supply works or water distribution systems
- 5 with respect to the life of such Authorities, the issuance of
- 6 bonds, the power of eminent domain, the laying of mains, the
- 7 relocation and vacation of roads, the abatement of certain
- 8 nuisances, the supplying of water to the public, and conferring
- 9 additional powers on the Secretary of Highways, municipalities,
- 10 the courts of quarter sessions, and courts of common pleas, with
- 11 respect to such Authorities."
- 12 Act of February 1, 1966 (1965 P.L.1656, No.581), known as The
- 13 Borough Code.
- 14 Section 3. This act shall take effect in 60 days.
