## AN ACT

- 1 Providing for the payment of interest on purchases by political subdivisions.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Political
- 7 Subdivision Procurement Interest Payment Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Business concern." Any person engaged in a trade or
- 13 business and operating as a contractor with a political
- 14 subdivision, or a nonprofit entity operating as a contractor
- 15 with a political subdivision.

- 1 "Local authority." A municipal authority or any other body
- 2 corporate and politically created by one or more political
- 3 subdivisions pursuant to statute.
- 4 "Payment made." A payment shall be considered made on the
- 5 date on which a check for such payment is dated.
- 6 "Political subdivision." Any county, city, borough,
- 7 incorporated town, township, school district, vocational school
- 8 district, county institution district, local authority or any
- 9 joint or cooperative body of political subdivisions having the
- 10 power to enter into contracts.
- 11 "Proper invoice." An invoice which contains or is
- 12 accompanied by such substantiating documentation as the
- 13 political subdivision involved may require by regulation or
- 14 contract.
- 15 "Qualified small business concern." Any independently owned
- 16 and operated for-profit business concern employing 100 or fewer
- 17 employees.
- 18 "Received invoice." Any invoice received by a political
- 19 subdivision on the later of:
- 20 (i) the date on which the political subdivision's
- 21 designated payment office or finance center actually receives
- 22 a proper invoice; or
- 23 (ii) the date on which the political subdivision accepts
- 24 the property or service concerned.
- 25 Section 3. Political subdivision interest payments.
- 26 (a) General rule.--
- 27 (1) In accordance with the provisions of paragraph (2),
- 28 each political subdivision which acquires property or
- 29 services from a business concern or a qualified small
- 30 business concern but which does not make payment for each

- complete delivered item of property or service by the required payment date shall pay an interest penalty to such
- 4 in accordance with this section on the amount of the payment

business concern and to any qualified small business concern,

5 which is due.

- 6 (2) All of the following conditions shall apply for the 7 payment of interest by a political subdivision:
  - (i) The required payment date shall be:
    - (A) the date on which payment is due under the terms of the contract for the provision of such property or service; or
    - (B) thirty calendar days after receipt of a proper invoice for the amount of the payment due, if a specific date on which payment is due is not established by contract.
  - (ii) Separate required payment dates for contracts under which property or services are provided in a series of partial executions or deliveries shall be established, to the extent that such contract provides for separate payment of such partial execution or delivery.
  - (iii) Prior to the date upon which payment without an interest penalty is due, a political subdivision shall notify the business concern or qualified small business concern of any defect in goods and services or impropriety in such invoice which would prevent the running of the time periods specified in this paragraph.
  - (iv) A qualified small business concern shall present on or with the invoice a statement that it meets the definition of a qualified small business concern contained in this section.

- 1 (b) Due date of payment.--
- 2 (1) Interest penalties payable on amounts due to a
- 3 business concern or qualified small business concern under
- 4 this section shall be paid to the business concern for the
- 5 period beginning on the day after the required payment date
- 6 and ending on the date on which payment on the amount due is
- 7 made.
- 8 (2) Interest shall be computed at the rate determined by
- 9 the Secretary of Revenue for interest payments on overdue
- 10 taxes or the refund of taxes as provided in sections 806 and
- 11 806.1 of the act of April 9, 1929 (P.L.343, No.176), known as
- 12 The Fiscal Code, and any subsequent amendments to those
- 13 sections.
- 14 (3) Interest may be paid by separate payment made to a
- business concern or qualified small business concern within
- 16 30 days of payment of the original invoice.
- 17 (4) Any amount of an interest penalty imposed because of
- 18 a debt which remains unpaid at the end of any 30-day period
- 19 shall be added to the principle amount of the debt and
- 20 thereafter interest penalties shall accrue on such added
- amount.
- 22 (c) Funds for interest payment.--A political subdivision
- 23 shall pay any interest penalties required by this section out of
- 24 funds made available for the administration or operation of the
- 25 program for which the penalty was incurred, or from general
- 26 administrative funds of the political subdivision. Nothing in
- 27 this section shall be construed to require payment of interest
- 28 penalties from Federal or State funds if such payment is
- 29 prohibited by Federal or State law or regulation.
- 30 (d) Claims.--Claims for interest penalties which a political

- 1 subdivision has failed to pay in accordance with the
- 2 requirements of this section shall be made in a formal civil
- 3 action against the offending political subdivision following the
- 4 exhaustion of all contractual remedies.
- 5 (e) Disputes.--This section shall not be construed to
- 6 require interest penalties on payments which are not made by the
- 7 required payment date by reason of a dispute between a political
- 8 subdivision and a business concern or qualified small business
- 9 concern over the amount of that payment or other allegations
- 10 concerning compliance with a contract.
- 11 Section 4. Nonapplication of act.
- 12 This act shall not apply to any "public contracts" subject to
- 13 the act of November 26, 1978 (P.L.1309, No.317), referred to as
- 14 the Public Works Contract Regulation Law.
- 15 Section 5. Applicability.
- 16 This act shall apply to all contracts entered into on or
- 17 after January 1, 1992.
- 18 Section 6. Effective date.
- 19 This act shall take effect in 60 days.
