AS AMENDED ON THIRD CONSIDERATION, HOUSE OF REPRESENTATIVES, JUNE 8, 1992

## AN ACT

- 1 Authorizing the release of Project 70 and Project 500
- 2 restrictions imposed on certain lands being conveyed by
- 3 Patton Township, Centre County, in return for the imposition
- 4 of Project 70 and Project 500 restrictions on certain lands
- being conveyed to Patton Township, Centre County.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Authorization.
- 9 The lands being conveyed by Patton Township, Centre County,
- 10 and described in section 2 are hereby released from restrictions
- 11 imposed under provisions of the act of June 22, 1964 (Sp.Sess.,
- 12 P.L.131, No.8), known as the Project 70 Land Acquisition and
- 13 Borrowing Act, and the act of January 19, 1968 (1967 P.L.996,
- 14 No.443), known as The Land and Water Conservation and
- 15 Reclamation Act, in exchange for the imposition of Project 70
- 16 and Project 500 restrictions on land to be conveyed to Patton
- 17 Township, Centre County, and described in section 3.
- 18 Section 2. Land to be released from restrictions.

- 1 The parcels of land authorized to be released from
- 2 restrictions are more particularly described as follows:
- 3 Three parcels of land situated in Patton Township, Centre
- 4 County, being more fully shown on a plan entitled "Property
- 5 Survey for Grayswood Partnership (Graysdale), prepared by
- 6 Sweetland Engineering & Associates, Inc., drawing number E-717,
- 7 dated April 10, 1991, revised October 9, 1991, and bounded and
- 8 described as follows:
- 9 Parcel Number 1
- 10 Beginning at an existing iron pipe in the northern right-of-
- 11 way line of Scotia Road (T.R.337), being a variable width right-
- 12 of-way, at the common eastern corner of lands now or formerly of
- 13 J. Alvin Hawbaker, being shown on the above mentioned plan, and
- 14 the southern corner of the herein described lot; thence along
- 15 said lands now or formerly of J. Alvin Hawbaker north 49 degrees
- 16 27 minutes 09 seconds west 65.35 feet to a point in the southern
- 17 line of lands now or formerly of the Township of Patton, park
- 18 area, Plan Book 16, Page 93, Deed Book 294, Page 1044, at the
- 19 common northern corner of said lands now or formerly of J. Alvin
- 20 Hawbaker and the western corner of said herein described lot;
- 21 thence along said lands now or formerly of the Township of
- 22 Patton (park area) north 42 degrees 18 minutes 49 seconds east
- 23 201.12 feet to an existing iron pipe at the northern corner of
- 24 said herein described lot; thence south 48 degrees 28 minutes 12
- 25 seconds east 69.31 feet to a point in said northern right-of-way
- 26 line of Scotia Road (T.R.337) at the eastern corner of said
- 27 herein described lot; thence along said northern right-of-way
- 28 line of Scotia Road (T.R.337) south 43 degrees 26 minutes 43
- 29 seconds west 200.09 feet to the point or place of beginning.
- 30 Containing 0.3099 acres, more or less.

- 3 Scotia Road (T.R.337), being a variable width right-of-way, at
- 4 the southern corner of the herein described lot, said point
- 5 being north 43 degrees 26 minutes 43 seconds east 217.20 feet
- 6 from an existing iron pipe at the eastern corner of lands now or
- 7 formerly of J. Alvin Hawbaker as shown on the above mentioned
- 8 plan; thence north 48 degrees 01 minutes 40 seconds west 69.61
- 9 feet to a point in the southern line of lands now or formerly of
- 10 the Township of Patton, park area, Plan Book 16, Page 93, Deed
- 11 Book 294, Page 1044, at the eastern corner of said herein
- 12 described lot; thence along said lands now or formerly of the
- 13 Township of Patton, park area, north 42 degrees 18 minutes 49
- 14 seconds east 273.00 feet to an existing iron pin at the common
- 15 western corner of lands nor NOW or formerly of Daniel R. and
- 16 Glenn O. Hawbaker, Calvin Zimmerman and Ralph T. Heimer and the
- 17 northern corner of said herein described lot; thence along said
- 18 lands now or formerly of Hawbaker, Zimmerman and Heimer south 46
- 19 degrees 17 minutes 06 seconds east 77.76 feet to a point in said
- 20 northern right-of-way line of Scotia Road (T.R.337) at the
- 21 common southern corner of said lands now or formerly of
- 22 Hawbaker, Zimmerman and Heimer and the eastern corner of said
- 23 herein described lot; thence along said northern right-of-way
- 24 line of Scotia Road (T.R.337) the following three (3) courses
- 25 and distances: (1) south 44 degrees 57 minutes 55 seconds west
- 26 109.81 feet to a point, said point being a point of curvature;
- 27 thence (2) by the arc of a curve to the left having an arc
- 28 length of 50.95 feet, a radius of 871.42 feet, a central angle
- 29 of 03 degrees 21 minutes 00 seconds, a chord distance of 50.94
- 30 feet and a chord bearing of south 43 degrees 17 minutes 27

- 1 seconds west to a point; thence (3) south 43 degrees 26 minutes
- 2 43 seconds west 110.07 feet to the point or place of beginning.
- 3 Containing 0.4541 acres, more or less.
- 4 Parcel Number 3
- 5 Beginning at an existing axle in the southwestern line of
- 6 lands now or formerly of Daniel R. Hawbaker, Glenn O. Hawbaker
- 7 Sr., Calvin Zimmerman and Ralph T. Heimer, Lot 10 Plan Book 33,
- 8 Page 170, at the common northern corner of other lands now or
- 9 formerly of Daniel R. Hawbaker, Glenn O. Hawbaker Sr., Calvin
- 10 Zimmerman and Ralph T. Heimer and the eastern corner of the
- 11 herein described lot; thence south 42 degrees 18 minutes 49
- 12 seconds west 660.00 feet to a point in the northern line of
- 13 lands now or formerly of J. Alvin Hawbaker, as shown on the
- 14 above mentioned plan, in the northwestern right-of-way line of a
- 15 60 foot right-of-way Plan Book 16, Page 93 at the southern
- 16 right-of-way line of said herein described lot; thence along
- 17 said northwestern right-of-way line of said 60 foot right-of-way
- 18 the following two (2) courses and distances: (1) north 47
- 19 degrees 52 minutes 43 seconds west 167.79 feet to a point;
- 20 thence (2) north 57 degrees 37 minutes 42 seconds west 400.00
- 21 feet to a point in line of lands now or formerly of Daniel R.
- 22 Hawbaker, Glenn O. Hawbaker Sr., Calvin Zimmerman and Ralph T.
- 23 Heimer Plan Book 9, Page 51 at the common northern corner of
- 24 said 60 foot right-of-way and the western corner of said herein
- 25 described lot; thence along said lands now or formerly of
- 26 Hawbaker, Zimmerman and Heimer the following three (3) courses
- 27 and distances: (1) north 32 degrees 31 minutes 04 seconds east
- 28 437.63 feet to a point; thence (2) north 41 degrees 07 minutes
- 29 19 seconds east 315.00 feet to a point at the northern corner of
- 30 said herein described lot; thence (3) south 46 degrees 12

- 2 corner of said lands now or formerly of Hawbaker, Zimmerman and
- 3 Heimer, Lot 10 Plan Book 33, Page 170; thence along said lands
- 4 now or formerly of Hawbaker, Zimmerman and Heimer, Lot 10 Plan
- 5 Book 33, Page 170, south 46 degrees 12 minutes 40 seconds east
- 6 521.23 feet to the point or place of beginning.
- 7 Containing 9.8522 acres, more or less.
- 8 Section 3. Land on which restrictions are to be imposed.
- 9 The parcel of land to be subject to restrictions is more
- 10 particularly described as follows:
- 11 A parcel of land situated in Patton Township, Centre County,
- 12 being more fully shown on a plan entitled "Graysdale Subdivision
- 13 Phase I" prepared by Fahringer, McCarty, Grey, Inc., dated
- 14 January 6, 1992, and bounded and described as follows:
- 15 Beginning at the most southerly corner of the proposed
- 16 Graysdale Subdivision, to be recorded, said corner also being on
- 17 the proposed northeasterly right-of-way line of Meeks Lane
- 18 30.000 feet to center line to be recorded in the aforementioned
- 19 Graysdale Subdivision and also being the southwesterly corner of
- 20 property now or formerly of State Game Lands No.176; thence from
- 21 said point of beginning along the northeasterly right-of-way
- 22 line of said Meeks Lane in a northwesterly direction by a curve
- 23 to the right having a radius of 320.000 feet for an arc distance
- 24 of 82.470 feet, subtended by a chord bearing of north 35 degrees
- 25 19 minutes 29 seconds west, for a chord distance of 82.240 feet;
- 26 thence along same north 27 degrees 56 minutes 30 seconds west
- 27 52.800 feet; thence along same in a northwesterly direction by a
- 28 curve to the left having a radius of 480.000 feet for an arc
- 29 distance of 214.255 feet; thence along same north 53 degrees 31
- 30 minutes 00 seconds west 28.195 feet to a point on the

- 1 southeasterly right-of-way line of Graysdale Boulevard 80 foot
- 2 width to be recorded in the aforementioned Graysdale
- 3 Subdivision; thence along said southeasterly right-of-way line
- 4 of Graysdale Boulevard in a northerly direction by a curve to
- 5 the right having a radius of 50.000 feet for an arc distance of
- 6 79.865 feet; thence along same north 37 degrees 59 minutes 58
- 7 seconds east 11.565 feet; thence along same in a northerly
- 8 direction by a curve to the left having a radius of 740.000 feet
- 9 for an arc distance of 396.605 feet; thence along same north 07
- 10 degrees 17 minutes 30 seconds east 58.945 feet; thence along
- 11 same in a northerly direction by a curve to the right having a
- 12 radius of 2400.000 feet for an arc distance of 333.010 feet;
- 13 thence along same in a northeasterly direction by a curve to the
- 14 right having a radius of 825.000 feet for an arc distance of
- 15 415.695 feet to a point on the center line of an existing 40
- 16 foot wide utility easement; thence along the center line of said
- 17 utility easement south 26 degrees 13 minutes 47 seconds east
- 18 915.570 feet to a point on line of lands now or formerly of
- 19 James A. and Nancy C. Bennett; thence along line of lands of
- 20 said James A. and Nancy C. Bennett, lands now or formerly of
- 21 Gary L. and Diane S. Hartman, land now or formerly of Richard P.
- 22 and Wanda K. Meyers and lands now or formerly of State Game
- 23 Lands No.176 south 42 degrees 18 minutes 49 seconds west 884.620
- 24 feet to the point of beginning.
- 25 Containing 14.103 acres, more or less.
- 26 Section 4. Deed restriction.
- 27 The restriction to be included in the deed to the parcel
- 28 described in section 3 shall read as follows:
- This indenture is given to provide land for recreation,
- 30 conservation and historical purposes as defined in the

- 1 act of June 22, 1964 (Sp.Sess., P.L.131, No.8), known as
- the Project 70 Land Acquisition and Borrowing Act, and
- 3 the act of January 19, 1968 (1967 P.L.996, No.443), known
- 4 as The Land and Water Conservation and Reclamation Act.
- 5 Section 5. Effective date.
- 6 This act shall take effect immediately.
