## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain
- 3 provisions applicable as well to private and parochial
- 4 schools; amending, revising, consolidating and changing the
- laws relating thereto, "further providing for construction or
- 6 contracts to construct or lease new school buildings or
- 7 substantial additions to existing buildings.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 701.1 of the act of March 10, 1949
- 11 (P.L.30, No.14), known as the Public School Code of 1949, added
- 12 June 27, 1973 (P.L.75, No.34), is amended to read:
- 13 Section 701.1. Referendum or Public Hearing Required Prior
- 14 to Construction or Lease. -- (a) Except where the approval of the
- 15 electors is obtained to incur indebtedness to finance the
- 16 construction of a school project, the board of school directors
- 17 of any school district of the second, third or fourth classes,

- 1 shall not construct, enter into a contract to construct or enter
- 2 into a contract to lease a new school building or substantial
- 3 addition to an existing school building without the consent of
- 4 the electors obtained by referendum or without holding a public
- 5 hearing as hereinafter provided. In the event that a new school
- 6 building or a substantial addition to an existing building is to
- 7 be constructed or leased, the school board shall, by a majority
- 8 vote of all its members, authorize a maximum project cost and a
- 9 maximum building construction cost to be financed by the
- 10 district or amortized by lease rentals to be paid by the
- 11 district. Building construction cost shall consist of the cost
- 12 of all building construction under the construction schedule and
- 13 for an additional three years, including general construction
- 14 costs, plumbing, heating, electrical, ventilating and other
- 15 structural costs, equipment and fixtures and architectural and
- 16 engineering fees relating thereto[, but not including].
- 17 Construction costs shall not include maintenance or
- 18 reconstruction work due to faulty work by contractors, costs for
- 19 site acquisition and development, rough grading to receive the
- 20 building, sewage treatment facilities or equivalent capital
- 21 contributions, and architectural and engineering fees relating
- 22 thereto. In all cases, a public hearing shall be held not later
- 23 than thirty (30) days before the school district submits the
- 24 initial building construction cost estimates to the Department
- 25 of Education for approval. Notice of the hearing shall be given
- 26 not later than twenty (20) days before the date of the scheduled
- 27 hearing. In the event that the maximum building construction
- 28 cost authorization exceeds the aggregate building expenditure
- 29 standard hereinafter specified, the aforesaid authorization of
- 30 the school board shall be submitted to the electors of the

- 1 school district for their approval within six (6) months prior
- 2 to submission of the final building construction cost bids to
- 3 the Department of Education for approval. Such referendum shall
- 4 be held in the same manner as provided by law for the approval
- 5 of the incurring of indebtedness by referendum. The question as
- 6 submitted shall specify the maximum project cost, the maximum
- 7 building construction cost and the annual sinking fund charge or
- 8 lease rental to be incurred by the school district and the
- 9 portion of such charge or rental expected to be reimbursed by
- 10 the Commonwealth. If the final building construction cost bids
- 11 to be submitted to the Department of Education for approval are
- 12 less than the aggregate building expenditure standard hereafter
- 13 specified but exceed by eight (8) per cent or more the initial
- 14 building construction cost estimates submitted to the Department
- 15 for approval, a second public hearing shall be held before the
- 16 Department shall give its final approval.
- 17 The applicable aggregate building expenditure standard shall
- 18 be a total amount calculated for each building or substantial
- 19 addition by multiplying the rated pupil capacity under the
- 20 approved room schedule by the following: two thousand eight
- 21 hundred dollars (\$2,800) for each pupil of rated elementary
- 22 capacity; four thousand two hundred dollars (\$4,200) for each
- 23 pupil of rated secondary capacity in grades seven, eight and
- 24 nine and five thousand two hundred dollars (\$5,200) for each
- 25 pupil of rated secondary capacity in grades ten, eleven and
- 26 twelve and five thousand two hundred dollars (\$5,200) for each
- 27 pupil of rated vocational-technical capacity in grades ten,
- 28 eleven and twelve to not include the cost of equipment and
- 29 fixtures in such vocational-technical schools: Provided,
- 30 however, That each of the preceding per pupil amounts shall be

- 1 adjusted by the Department of Education on July 1, 1974; and
- 2 annually thereafter by multiplying said amounts by the ratio of
- 3 the composite construction cost index compiled and published by
- 4 the United States Department of Commerce for the preceding
- 5 calendar year to such index for the next preceding calendar
- 6 year. Rated elementary pupil capacity or rated secondary pupil
- 7 capacity for any school building shall be the rated pupil
- 8 capacity determined on the basis of the method used by the
- 9 Department for school building reimbursement purposes during the
- 10 school year 1971-1972.
- 11 For purposes of this section:
- 12 (1) "Site acquisition" includes the cost of land and mineral
- 13 rights, demolition and clearing, rights-of-way and related
- 14 utility relocations, surveys and soils analysis, and the cost of
- 15 all fees relating thereto.
- 16 (2) "Site development" includes excavation, grouting or
- 17 shoring, special foundations for buildings, access roads to
- 18 site, utilities on site, extension of utilities to site.
- 19 (3) "Equipment and fixtures" means property fixed or movable
- 20 which is incidental and necessary to conduct the educational
- 21 program, and includes, but is not limited to movable equipment
- 22 such as desks, chairs, tables, portable physical education
- 23 equipment, audio-visual equipment and science, homemaking,
- 24 industrial art and business equipment and instructional
- 25 materials and fixtures such as casework, laboratory equipment,
- 26 kitchen equipment, auditorium seating and any other special
- 27 fixtures or equipment required to conduct a particular
- 28 educational program.
- 29 (4) "Substantial addition" means more than twenty (20) per
- 30 centum of the area and replacement value of the structure to

- 1 which the improvement is to be added.
- 2 (b) For the 1992-1993 school year, and each year thereafter,
- 3 the aggregate building expenditure standard shall be determined
- 4 by the Department of Education using projected student
- 5 <u>enrollment for the construction project. The Department of</u>
- 6 Education shall develop the method for determining projected
- 7 student enrollment to replace the method of determining the
- 8 rated pupil capacity and shall publish the method as a
- 9 regulation within six (6) months of the effective date of this
- 10 <u>subsection</u>. The Department of Education shall adjust the
- 11 aggregate building expenditure standard to reflect the
- 12 differences in changing from the rated pupil capacity to
- 13 projected student enrollment capacity for the 1992-1993 school
- 14 year. Increases in the expenditure standard shall be calculated
- 15 by increasing per pupil amounts as specified in subsection (a)
- 16 of this section.
- 17 Section 2. This act shall take effect July 1, 1993.
