## AN ACT

Amending the act of July 1, 1992 (P.L. , No.11A), entitled, "A supplement to the act of April 1, 1863 (P.L.213, No.227), 2 3 entitled 'An act to accept the grant of Public Lands, by the United States, to the several states, for the endowment of 5 Agricultural Colleges, 'making appropriations for carrying the same into effect; providing for a basis for payments of 7 such appropriations; and providing a method of accounting for the funds appropriated, " increasing appropriations for the 8 9 various programs and expenses at The Pennsylvania State 10 University. 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: 13 Section 1 of the act of July 1, 1992 (P.L. No.11A), entitled, "A supplement to the act of April 1, 1863 15 (P.L.213, No.227), entitled 'An act to accept the grant of Public Lands, by the United States, to the several states, for 16 17 the endowment of Agricultural Colleges, 'making appropriations for carrying the same into effect; providing for a basis for 18 19 payments of such appropriations; and providing a method of accounting for the funds appropriated," vetoed in part, is 20 21 amended to read:
