AN ACT

- 1 Authorizing and directing the Department of Corrections, with
- 2 the approval of the Governor, to convey to The Pennsylvania
- 3 State University a tract of land situate in Benner Township,
- 4 Centre County, Pennsylvania.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The Department of Corrections, with the approval
- 8 of the Governor, is hereby authorized and directed on behalf of
- 9 the Commonwealth of Pennsylvania to convey to The Pennsylvania
- 10 State University the following tract of land situate in Benner
- 11 Township, Centre County, Pennsylvania, for a consideration of
- 12 one-half of the fair market value, the following:
- 13 All that certain parcel or tract of land lying 0.4 miles
- 14 southeasterly of the University Park Airport and along the
- 15 westerly side of a portion of Benner Township Road 376, known
- 16 locally as Rock Road, situate in Benner Township, Centre County,
- 17 Pennsylvania, more particularly bounded and described as
- 18 follows:
- 19 Beginning at the most easterly reference monument of the

- 1 University Park Airport, thence south 44 degrees 05 minutes 53
- 2 seconds east, a distance of 2130.54 feet, more or less, to an
- 3 iron pipe in stones, the true place of beginning, thence north
- 4 55 degrees 57 minutes east, a distance of 2802.63 feet, more or
- 5 less, thence north 81 degrees 35 minutes east, a distance of
- 6 170.78 feet, more or less, thence north 72 degrees 05 minutes
- 7 east, a distance of 170 feet, more or less, thence south 18
- 8 degrees 55 minutes east, a distance of 13 feet, more or less,
- 9 thence north 71 degrees 05 minutes east, a distance of 276 feet,
- 10 more or less, to a point in a public road, Benner Township Road
- 11 376, known locally as Rock Road, thence by aforesaid road the
- 12 following courses and distances; south 56 degrees 09 minutes 47
- 13 seconds east, a distance of 156.63 feet, more or less, a curve I
- 14 = 17 degrees 02 minutes 54 seconds right, radius 891.74 feet,
- 15 chord south 58 degrees 16 minutes 51 seconds east; a distance of
- 16 264.36 feet, more or less, a curve I = 25 minutes 38 seconds
- 17 left, radius 48,135.72 feet, chord south 49 degrees 45 minutes
- 18 24 seconds east, a distance of 358.92 feet, more or less, south
- 19 49 degrees 32 minutes 35 seconds east, a distance of 208.45
- 20 feet, more or less, a curve I = 17 degrees 25 minutes 08 seconds
- 21 left, radius 531.35 feet, chord south 58 degrees 15 minutes 9
- 22 seconds east, a distance of 160.92 feet, more or less, south 66
- 23 degrees 57 minutes 44 seconds east, a distance of 1,185.77 feet,
- 24 more or less, a curve I = 120 degrees 38 minutes 50 seconds
- 25 right, radius 150.44 feet, chord south 06 degrees 38 minutes 19
- 26 seconds east, a distance of 261.42 feet, more or less, south 53
- 27 degrees 41 minutes 07 seconds west, a distance of 468.72 feet,
- 28 more or less, a curve I = 27 degrees 29 minutes 20 seconds
- 29 right, radius 372.76 feet, chord south 34 degrees 50 minutes 13
- 30 seconds west, a distance of 264.03 feet, more or less, south 11

- 1 degrees 29 minutes 59 seconds east, a distance of 457.30 feet,
- 2 more or less, a curve I = 17 degrees 05 minutes 11 seconds
- 3 right, radius 976.24 feet, chord south 02 degrees 57 minutes 24
- 4 seconds east, a distance of 290.05 feet, more or less, south 05
- 5 degrees 35 minutes 12 seconds west, a distance of 213.69 feet,
- 6 more or less, a curve I = 39 degrees 51 minutes 56 seconds left,
- 7 radius 259.40 feet, chord south 14 degrees 20 minutes 46 seconds
- 8 east, a distance of 176.87 feet, more or less, thence leaving
- 9 said public road south 49 degrees 32 minutes west, a distance of
- 10 2,660.89 feet, more or less, to an iron pin at a fence corner
- 11 post, thence north 33 degrees 51 minutes west, a distance of
- 12 3,622.15 feet, more or less to an iron pipe in stones, the true
- 13 place of beginning, containing 288 acres, more or less,
- 14 including that portion of the assumed 33-foot right-of-way of
- 15 the aforesaid public road lying within the description herein
- 16 according to a survey by Lloyd S. Houk, dated March 6, 1992.
- 17 Being a portion of lands transferred to the Commonwealth of
- 18 Pennsylvania, by deed recorded in Centre County Deed Book 113 at
- 19 page 19.
- 20 Section 2. The conveyance shall be made under and subject to
- 21 all easements, servitudes and rights of others, including, but
- 22 not confined to, streets, roadways and rights of any telephone,
- 23 telegraph, water, electric, sewer, gas or pipeline companies, as
- 24 well as under and subject to any interest, estates or tenancies
- 25 vested in third persons, whether or not appearing of record, for
- 26 any portion of the land or improvements erected thereon.
- 27 Section 3. The deed of conveyance shall contain a clause
- 28 that the property conveyed shall be used for educational and
- 29 related purposes by The Pennsylvania State University and if at
- 30 any time The Pennsylvania State University or its successor in

- 1 function conveys the property or permits the property to be used
- 2 for any purpose other than those specified in this section, the
- 3 title to the property shall immediately revert to and revest in
- 4 the Commonwealth of Pennsylvania; provided, that the grantee may
- 5 secure abrogation of this condition subsequent by payment to the
- 6 Commonwealth of Pennsylvania of an amount equal to the
- 7 consideration paid for this conveyance.
- 8 Section 4. The deed of conveyance shall be approved as
- 9 provided by law and shall be executed by the Secretary of
- 10 General Services in the name of the Commonwealth of
- 11 Pennsylvania.
- 12 Section 5. Costs and fees incidental to this conveyance
- 13 shall be borne by the grantee.
- 14 Section 6. This act shall take effect in 60 days.
