## AN ACT

1 Amending the act of August 26, 1971 (P.L.351, No.91), entitled  
2 "An act providing for a State Lottery and administration  
3 thereof; authorizing the creation of a State Lottery  
4 Commission; prescribing its powers and duties; disposition of  
5 funds; violations and penalties therefor; exemption of prizes  
6 from State and local taxation and making an appropriation,"  
7 ~~imposing restrictions on the resale of lottery tickets or~~ <—  
8 ~~shares; prohibiting the sale of lottery tickets from other~~  
9 ~~jurisdictions; and increasing certain penalties.~~ PROVIDING <—  
10 FOR CERTAIN APPLICATIONS FOR LOTTERY MACHINES AND FOR A  
11 COMPACT TO SELL TICKETS.

12 THE GENERAL ASSEMBLY OF THE COMMONWEALTH OF PENNSYLVANIA

13 HEREBY ENACTS AS FOLLOWS:

14 ~~SECTION 1. SECTION 9 OF THE ACT OF AUGUST 26, 1971 (P.L.351,~~ <—  
15 ~~NO.91), KNOWN AS THE STATE LOTTERY LAW, AMENDED DECEMBER 15,~~  
16 ~~1982 (P.L.1288, NO.291), IS AMENDED TO READ:~~

17 ~~SECTION 9. SALES OF TICKETS IN EXCESS OF REGULATED PRICE;~~  
18 ~~SALES BY NON LICENSED PERSONS; PENALTIES. (A) NO PERSON SHALL~~  
19 ~~SELL [A TICKET OR SHARE], RESELL OR ENGAGE IN THE BUSINESS OF~~  
20 ~~RESELLING LOTTERY TICKETS OR SHARES AT A PRICE GREATER THAN THAT~~

1 ~~FIXED BY RULE OR REGULATION OF THE DEPARTMENT. PRICE SHALL~~  
2 ~~INCLUDE ANY FEE ASSOCIATED WITH THE ACQUISITION OR~~  
3 ~~TRANSPORTATION OF TICKETS OR SHARES.~~

4 ~~(B) NO PERSON OTHER THAN A LICENSED LOTTERY SALES AGENT~~  
5 ~~SHALL SELL LOTTERY TICKETS OR SHARES, EXCEPT THAT NOTHING IN~~  
6 ~~THIS SECTION SHALL BE CONSTRUED TO PREVENT ANY PERSON FROM~~  
7 ~~GIVING LOTTERY TICKETS OR SHARES TO ANOTHER AS A GIFT.~~

8 ~~(C) NO PERSON SHALL ENGAGE IN THE SALE OR OFFERING FOR SALE~~  
9 ~~WITHIN THIS COMMONWEALTH OF ANY INTEREST IN A LOTTERY OF ANOTHER~~  
10 ~~STATE OR GOVERNMENT WHETHER OR NOT SUCH INTEREST IS AN ACTUAL~~  
11 ~~LOTTERY TICKET, RECEIPT, CONTINGENT PROMISE TO PAY, ORDER TO~~  
12 ~~PURCHASE OR OTHER RECORD OF SUCH INTEREST.~~

13 ~~(D) ANY PERSON CONVICTED OF VIOLATING THIS SECTION SHALL BE~~  
14 ~~GUILTY OF A MISDEMEANOR AND UPON CONVICTION THEREOF, SHALL BE~~  
15 ~~SENTENCED TO PAY A FINE NOT EXCEEDING [FIVE HUNDRED DOLLARS~~  
16 ~~(\$500).] TWO THOUSAND DOLLARS (\$2,000).~~

17 ~~SECTION 2. THIS ACT SHALL TAKE EFFECT IN 60 DAYS.~~

18 SECTION 1. SECTION 7 OF THE ACT OF AUGUST 26, 1971 (P.L.351, <—  
19 NO.91), KNOWN AS THE STATE LOTTERY LAW, IS AMENDED BY ADDING A  
20 SUBSECTION TO READ:

21 SECTION 7. LOTTERY SALES AGENTS; QUALIFICATIONS;  
22 PROHIBITIONS.--\* \* \*

23 ~~(E) ANY PERSON WHO HAS A PENDING APPLICATION FOR A LOTTERY~~  
24 ~~MACHINE AND IS CURRENTLY ENGAGED IN THE SALE OF OUT-OF-STATE~~  
25 ~~LOTTERY TICKETS MAY SUBMIT A WRITTEN REQUEST TO THE DEPARTMENT~~  
26 ~~OF REVENUE FOR A RESURVEY. THIS RESURVEY SHALL BE COMPLETED BY~~  
27 ~~THE DEPARTMENT WITHIN NINETY DAYS OF RECEIPT OF THE REQUEST.~~  
28 ~~OUT-OF-STATE LOTTERY TICKETS MAY BE SOLD BY THAT PERSON DURING~~  
29 ~~THIS PERIOD.~~

30 SECTION 2. THE ACT IS AMENDED BY ADDING A SECTION TO READ:

1     SECTION 9.1. COMPACT TO SELL TICKETS.--THE SECRETARY SHALL  
2     ENTER INTO A COMPACT WITH ANY OTHER STATES THAT PERMIT SALE OF  
3     PENNSYLVANIA LOTTERY TICKETS WITHIN THEIR BORDERS TO SELL THOSE  
4     STATES' LOTTERY TICKETS WITHIN THIS COMMONWEALTH.

5     SECTION 3. THIS ACT SHALL TAKE EFFECT AS FOLLOWS:

6             (1) THE AMENDMENT OF SECTION 7 OF THE ACT SHALL TAKE  
7     EFFECT IMMEDIATELY.

8             (2) THE REMAINDER OF THIS ACT SHALL TAKE EFFECT IN 60  
9     DAYS.
