AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, further providing for acknowledgment
- 3 of paternity.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 5103 of Title 23 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a subsection to read:
- 8 § 5103. Acknowledgment and claim of paternity.
- 9 * * *
- 10 (c) Acknowledgment upon birth.--Upon the birth of a child to
- 11 an unmarried woman, the attending physician or midwife, an agent
- 12 of either or an agent of the hospital where the birth occurred
- 13 shall:
- (1) Provide the newborn's mother and natural father with
- an opportunity to complete an affidavit acknowledging

| 1 | paternity. The completed, signed affidavit shall be filed |

| 2 | with the Division of Vital Records in the Department of |
| 3 | Health. A copy shall be given to the mother and natural |
| 4 | father separately. This affidavit shall contain: |
| 5 | (i) A sworn, signed statement by the mother |

| LO | (iii) A written explanation of the implications of |

| L4 | numbers and addresses of both parents. |
| L5 | (2) Provide written information, furnished by the |
| L6 | Department of Public Welfare to the mother, which explains |
| L7 | the benefits of having her child's paternity established, the |
| L8 | availability of paternity establishment services and the |
| L9 | availability of child support enforcement agencies. |
| 2.0 | Section 2 This act shall take effect in 60 days |
