## AN ACT

1 Amending Title 42 (Judiciary and Judicial Procedure) of the  
2 Pennsylvania Consolidated Statutes, providing for selection  
3 of prospective jurors.

4 The General Assembly of the Commonwealth of Pennsylvania  
5 hereby enacts as follows:

6 Section 1. Section 4521(a) of Title 42 of the Pennsylvania  
7 Consolidated Statutes is amended to read:

8 § 4521. Selection of prospective jurors.

9 ~~(a) Preparation of master list of prospective jurors. At~~ <—

10 (A) PREPARATION OF MASTER LIST OF PROSPECTIVE JURORS.-- <—

11 (1) AT least annually the jury selection commission  
12 shall prepare a master list of prospective jurors. The MASTER <—

13 list shall contain [all voter registration lists for] ~~the~~ <—

14 ~~names of all drivers licensed in~~ the county, [which lists may <—

15 be incorporated by reference,] or names from such other lists <—

1 which in the opinion of the commission will provide a number  
2 of names of prospective jurors which is equal to or greater  
3 than the number of names contained in the {voter <—  
4 registration} ~~licensed driver~~ list. The commission may, but <—  
5 will not be required to, supplement the master list of  
6 prospective jurors to include, without being limited to,  
7 persons in any of the following categories:] THE NAMES OF ALL <—  
8 PERSONS LISTED IN ANY TWO OR MORE OF THE FOLLOWING  
9 CATEGORIES:

10 (I) PERSONS LISTED ON VOTER REGISTRATION LISTS.

11 (II) PERSONS WHO ARE DRIVERS LICENSED IN THE COUNTY  
12 AND WHO ARE 18 YEARS OF AGE OR OLDER.

13 [(1)] (III) Persons listed in telephone, city, municipal <—  
14 directories and similar directories.

15 [(2)] (IV) Persons who pay taxes or are assessed for <—  
16 taxes imposed by any political subdivisions.

17 [(3)] (V) Persons in the county participating in any <—  
18 State, county or local program authorized by law and, to the  
19 extent such names are available, persons participating in any  
20 Federal program authorized by law.

21 [(4)] (VI) Persons who are on school census lists. <—

22 [(5)] (2) Any other person whose name does not appear in <—  
23 the master list of prospective jurors and who meets the  
24 qualifications for jurors set forth in this chapter [and who <—  
25 makes] MAY MAKE application to the commission to be listed on <—  
26 the master list of prospective jurors.

28 Section 2. This act shall take effect in 60 days.
