AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- 2 act relating to the public school system, including certain
- 3 provisions applicable as well to private and parochial
- 4 schools; amending, revising, consolidating and changing the
- 5 laws relating thereto, providing for a nonprofit school
- 6 breakfast program.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 Section 1337.1. Nonprofit School Breakfast Program. -- (a)
- 13 For the 1993-1994 school year and each year thereafter, each
- 14 school district in this Commonwealth shall make the benefits of
- 15 the national school breakfast program provided by the Child
- 16 <u>Nutrition Act of 1966 (Public Law 89-642, 42 U.S.C. § 1771 et</u>
- 17 seq.) available to all students at all grade levels.
- 18 (b) An individual school may apply to the Department of

- 1 Education for a one-time waiver from the requirements of
- 2 <u>subsection (a)</u>. The Secretary of Education shall give notice and
- 3 an opportunity to be heard to the parents and the school. The
- 4 <u>Secretary of Education shall not grant a waiver unless the</u>
- 5 school demonstrates special circumstances that would prevent
- 6 <u>implementation of a school breakfast program.</u>
- 7 (c) The requirements of subsection (a) shall not apply when
- 8 Federal financial appropriations for school breakfast programs
- 9 are terminated. Nothing in this section shall prohibit a school
- 10 <u>district from initiating or continuing school breakfast programs</u>
- 11 <u>at its own expense.</u>
- 12 (d) As used in this section, the term "school breakfast
- 13 program" means a program under which breakfast food is served by
- 14 <u>a school on a nonprofit basis to children in attendance,</u>
- 15 <u>including any such program under which a school receives</u>
- 16 <u>assistance out of funds appropriated by the Congress of the</u>
- 17 <u>United States.</u>
- 18 Section 2. On or before October 15 of each year, the
- 19 Department of Education shall submit a report on the previous
- 20 school year's school breakfast program to the General Assembly.
- 21 The report shall include the department's findings and
- 22 recommendations.
- 23 Section 3. The provisions of this act shall be implemented
- 24 within six months of the effective date of this act.
- 25 Section 4. This act shall take effect immediately.
