25	Section 1. Section 3(i) of the act of May 17, 1956 (1955
26	P.L.1609, No.537), known as the Pennsylvania Industrial

Development Authority Act, amended June 16, 1972 (P.L.475,
 No.153), is amended and the section is amended by adding a
 subsection to read:

Section 3. Definitions.--The following terms, whenever used
or referred to in this act, shall have the following meanings,
except in those instances where the context clearly indicates
otherwise:

8 * * *

(i) The term "industrial development project" shall mean any 9 10 land, site, structure, facility or undertaking comprising or 11 being connected with or being a part of (i) an industrial enterprise, (ii) a manufacturing enterprise, (iii) a research 12 13 and development enterprise, [or] (iv) an agricultural 14 enterprise, or (v) a travel and tourism enterprise, established 15 or to be established by an industrial development agency in a critical economic area. 16

18 (v) The term "travel and tourism enterprise" shall mean a
19 long-term project or activity devoted to the enhancement of this
20 Commonwealth's travel and tourism industry and related
21 recreational activities if it provides full-time, year-round
22 employment and results in the importation of capital to this
23 Commonwealth.
24 Section 2. This act shall take effect in 60 days.
