AN ACT

- Amending the act of May 17, 1921 (P.L.789, No.285), entitled, as amended, "An act relating to insurance; establishing an 3 insurance department; and amending, revising, and consolidating the law relating to the licensing, qualification, regulation, examination, suspension, and dissolution of insurance companies, Lloyds associations, 7 reciprocal and inter-insurance exchanges, and certain societies and orders, the examination and regulation of fire 9 insurance rating bureaus, and the licensing and regulation of insurance agents and brokers; the service of legal process 10 upon foreign insurance companies, associations or exchanges; 11 12 providing penalties, and repealing existing laws, " further 13 providing for penalties for acting without certificate of 14 authority; providing for the licensing of insurance 15 administrators; and further providing for issuance of certificate of qualification and for certain penalties. 16 17 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 18
- 19 Section 1. Section 209 of the act of May 17, 1921 (P.L.789,
- 20 No. 285), known as The Insurance Department Act of 1921, amended
- 21 June 23, 1976 (P.L.414, No.95), is amended to read:
- 22 Section 209. Penalty for Acting Without Certificate of

- 1 Authority. --(a) Any insurance company, association, or exchange
- 2 doing an insurance business within this Commonwealth without a
- 3 certificate of authority as required by this act shall be
- 4 required to pay a civil penalty of not less than one thousand
- 5 dollars (\$1,000) nor more than ten thousand dollars (\$10,000)
- 6 for each offense, to be recovered on behalf of the Commonwealth.
- 7 (b) Any person negotiating or soliciting any policy of
- 8 insurance or suretyship in this Commonwealth, collecting or
- 9 forwarding premiums or delivering policies for any company,
- 10 association, or exchange to which a certificate of authority has
- 11 not been granted, shall be deemed to be the agent of the
- 12 company, association, or exchange, in any legal proceedings
- 13 brought against it. Such person shall be required to pay a civil
- 14 penalty of not less than one thousand dollars (\$1,000) nor more
- 15 than ten thousand dollars (\$10,000) for each offense to be
- 16 recovered on behalf of the Commonwealth.
- 17 [Before the Insurance Commissioner shall take any action, as
- 18 above set forth, he shall give written notice to the company,
- 19 association or exchange or person accused of violating the law,
- 20 stating the nature of such alleged violation, and fixing a time
- 21 and place, at least ten days thereafter, when a hearing of the
- 22 matter shall be held. After such hearing or failure of the
- 23 accused to appear at such hearing, the Insurance Commissioner
- 24 shall impose such penalty as he deems advisable.]
- 25 <u>(c) Whenever the Insurance Commissioner has articulable</u>
- 26 evidence that any person, insurance company, association or
- 27 exchange has or is doing an insurance business within this
- 28 Commonwealth without a certificate of authority as required by
- 29 this act, or has or is violating any order or requirement of the
- 30 <u>Insurance Commissioner issued or promulgated pursuant to</u>

- 1 authority expressly granted the Insurance Commissioner by this
- 2 section and that the interests of policyholders, creditors or
- 3 the public may be irreparably harmed by delay, the Insurance
- 4 Commissioner may issue a cease and desist order. Notice of the
- 5 cease and desist order and notice of hearing shall be served by
- 6 first class mail.
- 7 (d) Unless mutually agreed upon by the Insurance Department
- 8 and the insurance company, association, exchange or person, the
- 9 <u>hearing shall be held not more than fifteen days after issuance</u>
- 10 of the order. Any adjudication of the Insurance Commissioner
- 11 under this subsection shall be in accordance with and subject to
- 12 review and appeal in accordance with 2 Pa.C.S. Ch. 5 Subch. A
- 13 <u>(relating to practice and procedure of Commonwealth agencies)</u>
- 14 and Ch. 7 Subch. A (relating to judicial review of Commonwealth
- 15 <u>agency action</u>).
- 16 (e) Upon satisfactory evidence that any person, insurance
- 17 company, association or exchange has willfully violated a cease
- 18 and desist order issued under subsection (c), the Insurance
- 19 Commissioner may, in his discretion, impose a civil penalty of
- 20 not more than five thousand dollars (\$5,000) for each and every
- 21 act in violation of the cease and desist order.
- 22 Section 2. Sections 604(a) and 639(a) of the act, amended
- 23 July 11, 1992 (P.L.284, No.48), are amended to read:
- 24 Section 604. Issuance of Certificate of Qualification.--(a)
- 25 When the Insurance Department is satisfied that the applicant is
- 26 worthy of a certificate of qualification and has successfully
- 27 passed an examination and otherwise complied with this article,
- 28 it shall issue a certificate. The certificate shall state that
- 29 the agent has complied with this article and has been authorized
- 30 by the Insurance Department to transact business in specific

- 1 lines of authority in this Commonwealth. Once a certificate is
- 2 <u>issued</u>, the certificate holder is presumed worthy to secure
- 3 <u>additional specific lines of authority under the certificate</u>
- 4 unless the department files an action to suspend or revoke or
- 5 refuse to renew the certificate pursuant to section 639 of this
- 6 act.
- 7 * * *
- 8 Section 639. Penalties Imposed by Insurance Department.--(a)
- 9 Upon satisfactory evidence of the violation of sections 602,
- 10 605, 606, 608, 609, 622 and 631 through 638 by any agent of any
- 11 insurance entity or by any insurance broker or upon satisfactory
- 12 evidence of such conduct that would disqualify the agent or
- 13 broker from initial issuance of a certificate of qualification
- 14 under section 604 or 622, the department may pursue any one or
- 15 more of the following courses of action regardless of whether
- 16 the agent or broker was so authorized by the department:
- 17 (1) Suspend or revoke or refuse to [issue] renew the
- 18 certificate of qualification or license of the offending party
- 19 or parties.
- 20 (2) Impose a civil penalty of not more than one thousand
- 21 dollars (\$1,000.00) for each act in violation of any of the
- 22 provisions listed in this subsection.

- 24 Section 3. The act is amended by adding an article to read:
- 25 ARTICLE X.
- 26 <u>INSURANCE ADMINISTRATOR LICENSURE.</u>
- 27 Section 1001. Short Title.--This article shall be known and
- 28 may be cited as the "Insurance Administrator Licensure Act."
- 29 Section 1002. Definitions.--The following words and phrases
- 30 when used in this article shall have the meanings given to them

- 1 in this section unless the context clearly indicates otherwise:
- 2 <u>"Administrator" means any person who collects charges or</u>
- 3 premiums from or who adjusts or settles claims for residents of
- 4 this Commonwealth in connection with life or health coverage or
- 5 annuities. The term shall specifically include any person who
- 6 collects charges or premiums from or who adjusts or settles
- 7 claims for residents of this Commonwealth in connection with
- 8 <u>life or health coverages or annuities provided by or through an</u>
- 9 <u>employe benefit plan, including, but not limited to, multiple</u>
- 10 employer welfare arrangements and self-insured municipalities or
- 11 other political subdivisions. The term shall not include any of
- 12 the following:
- 13 (1) An employer on behalf of its employes or the employes of
- 14 one or more subsidiary or affiliated corporations of such
- 15 <u>employer</u>.
- 16 (2) A union on behalf of its members.
- 17 (3) An insurance company which is either licensed in this
- 18 Commonwealth or acting as an insurer with respect to a policy
- 19 lawfully issued and delivered by it and pursuant to the laws of
- 20 <u>a state in which the insurer was authorized to do an insurance</u>
- 21 <u>business</u>.
- 22 (4) Professional health services plan corporations organized
- 23 under 40 Pa.C.S. Ch. 63 (relating to professional health
- 24 <u>services plan corporations</u>) or hospital plan corporations
- 25 organized under Ch. 61 (relating to hospital plan corporations),
- 26 <u>subject to any limitations imposed by Chs. 61 and 63.</u>
- 27 (5) A life or health agent or broker licensed in this
- 28 Commonwealth, whose activities are limited exclusively to the
- 29 <u>sale of insurance.</u>
- 30 (6) A creditor on behalf of its debtors with respect to

- 1 insurance covering a debt between the creditor and its debtors.
- 2 (7) A trust, its trustees and employes acting thereunder
- 3 established in conformity with section 302 of the Labor
- 4 Management Relations Act, 1947 (61 Stat. 136, 29 U.S.C. 186).
- 5 (8) A trust exempt from taxation under section 501(a) of the
- 6 Internal Revenue Code of 1954 (68A Stat. 3, 26 U.S.C.), its
- 7 trustees, and employes acting thereunder, or a custodian, its
- 8 agents and employes acting pursuant to a custodian account which
- 9 meets the requirements of section 401(f) of the Internal Revenue
- 10 <u>Code of 1954.</u>
- 11 (9) A bank, credit union or other financial institution
- 12 which is subject to supervision or examination by Federal or
- 13 State banking authorities.
- 14 (10) A credit card issuing company which advances for its
- 15 credit cardholders and collects premiums or charges from its
- 16 <u>credit cardholders who have authorized it to do so, provided</u>
- 17 such company does not adjust or settle claims.
- 18 (11) A person who adjusts or settles claims in the normal
- 19 course of his practice or employment as an attorney-at-law and
- 20 who does not collect charges or premiums in connection with life
- 21 <u>and health insurance coverage or annuities.</u>
- 22 (12) A person licensed as an insurance agent and who has
- 23 been appointed by an insurer to act as a managing general agent
- 24 <u>in this Commonwealth, whose activities are limited exclusively</u>
- 25 to the scope of activities conveyed under that license.
- 26 <u>"Benefit plan" means an insured or wholly or partially self-</u>
- 27 funded coverage plan which, by means of direct payment,
- 28 reimbursement or other arrangement, provides partial or complete
- 29 coverage for services, including, but not limited to, medical,
- 30 surgical, chiropractic, physical therapy, speech pathology,

- 1 audiology, professional mental health, dental, hospital or
- 2 <u>vision care or for drugs or other items reasonably related</u>
- 3 thereto.
- 4 "Commissioner" means the Insurance Commissioner of the
- 5 Commonwealth.
- 6 "Department" means the Insurance Department of the
- 7 <u>Commonwealth</u>.
- 8 Section 1003. License Required; Application; Unlicensed
- 9 Activity. -- On and after the effective date of this act, no
- 10 person shall act as or hold himself out to be an administrator
- 11 <u>in this Commonwealth, other than an adjuster licensed in this</u>
- 12 Commonwealth for the kinds of business for which he is acting as
- 13 <u>an administrator, unless he shall hold a license as an</u>
- 14 administrator issued by the department. The license shall be
- 15 renewable biennially. The license shall be issued by the
- 16 <u>department to an administrator unless the department determines</u>
- 17 that the administrator is not competent, trustworthy,
- 18 financially responsible or of good personal and business
- 19 reputation or has had a previous application for an insurance
- 20 <u>license denied for cause within five years. All applications</u>
- 21 <u>shall be accompanied by a filing fee of one hundred dollars</u>
- 22 (\$100). An applicant whose license is denied may request a
- 23 hearing pursuant to 2 Pa.C.S. (relating to administrative law
- 24 and procedure).
- 25 Section 1004. Financial Responsibility and Security
- 26 Requirements. -- All administrators shall be required to maintain
- 27 an errors and omissions insurance policy and also to maintain
- 28 <u>financial responsibility in the form of a fidelity bond or a</u>
- 29 clean irrevocable and unconditional and ever-green letter of
- 30 credit or, as established by regulation, other form of security

- 1 acceptable to the department. Financial responsibility shall be
- 2 <u>established and maintained each year in an amount equal to fifty</u>
- 3 per centum of the average amount of funds entrusted to the
- 4 administrator by benefit plans for the preceding twelve months,
- 5 but not to exceed five hundred thousand dollars (\$500,000) for
- 6 any plans other than multiple employer welfare arrangements.
- 7 <u>Section 1005. Written Agreement Necessary. -- An administrator</u>
- 8 must have a written agreement between the administrator and the
- 9 <u>entity providing the benefit plan. The written agreement shall</u>
- 10 be retained as part of the official records of the administrator
- 11 <u>for the duration of the agreement and five years thereafter. The</u>
- 12 <u>written agreement shall comply with the requirements of this</u>
- 13 <u>act. Where an insurance policy is issued to a trustee or</u>
- 14 trustees, a copy of the trust agreement and any amendments
- 15 thereto shall be furnished to the insurer by the administrator
- 16 and shall be retained as part of the official records of both
- 17 the benefit plan and the administrator for the duration of the
- 18 contract and five years thereafter.
- 19 Section 1006. Payment to Administrator. -- The payment to the
- 20 <u>administrator of any premiums or charges for benefit coverage by</u>
- 21 or on behalf of those persons covered by the benefit plan shall
- 22 be deemed to have been received by the benefit plan, and the
- 23 payment of return premiums, charges or claims by the benefit
- 24 plan to the administrator shall not be deemed payment to the
- 25 person or claimant until the payments are received by the person
- 26 or claimant. Nothing in this section shall limit any right of a
- 27 benefit plan against the administrator resulting from its
- 28 <u>failure to make payments to the benefit plan, those persons</u>
- 29 <u>covered by the benefit plan or claimants.</u>
- 30 <u>Section 1007. Maintenance of Information; Examination.--</u>

- 1 Every administrator shall maintain, at its principal
- 2 <u>administrative office for the duration of the written agreement</u>
- 3 referred to in section 1005 and five years thereafter, adequate
- 4 books of all transactions and records of all transactions
- 5 between it, the benefit plan and persons covered under the
- 6 benefit plan. The commissioner shall have access to all books
- 7 and records which are the property of administrators required to
- 8 be maintained by this act for the purpose of examination, audit,
- 9 <u>inspection and investigation</u>. Books and records, the property of
- 10 bona fide employe benefit plans established by an employer or
- 11 employe organization, or both, may be available to the
- 12 <u>department for audit, inspection, examination or investigation</u>
- 13 at the option of the employer or employe organization. Nothing
- 14 in this subsection is intended to abridge or interfere with the
- 15 department's authority to review all records necessary to
- 16 <u>determine jurisdiction over any entity that may be subject to</u>
- 17 this or other insurance laws generally. Expenses incurred by the
- 18 department in examination of administrators shall be paid by the
- 19 administrator in the same manner, and in the same amounts,
- 20 pursuant to the examination provisions of this act and
- 21 <u>applicable regulations. Trade secrets, including the identity</u>
- 22 and addresses of policyholders and certificate holders, will be
- 23 treated as confidential by the department, except the department
- 24 may use that information in proceedings instituted against the
- 25 <u>administrator</u>. The entity providing the benefit plan shall
- 26 retain the right to continuing access to the books and records
- 27 of the administrator sufficient to permit the benefit plan to
- 28 <u>fulfill all of its contractual obligations to the persons</u>
- 29 covered under the benefit plan, subject to any restrictions in
- 30 the written agreement between the entity providing the benefit

- 1 plan and the administrator on the proprietary rights of the
- 2 parties in the books and records.
- 3 <u>Section 1008</u>. Approval of Advertising. -- The administrator
- 4 may use only advertising or solicitation materials of persons
- 5 <u>covered by a benefit plan as has been approved in advance by the</u>
- 6 <u>entity providing the benefit plan.</u>
- 7 <u>Section 1009. Premium Collection.--All charges or premiums</u>
- 8 collected by an administrator on behalf of or for a benefit plan
- 9 and return charges or premiums received from a benefit plan
- 10 shall be held by the administrator in a fiduciary capacity. The
- 11 <u>funds shall be immediately remitted to the person or persons</u>
- 12 <u>entitled thereto or shall be deposited promptly in one or more</u>
- 13 appropriately identified bank accounts in banks that are members <-

- 14 of the Federal Reserve System OR OTHER FINANCIAL INSTITUTIONS
- 15 WHICH ARE SUBJECT TO SUPERVISION OR EXAMINATION BY FEDERAL OR
- 16 STATE BANKING REGULATORY AUTHORITIES. If charges or premiums so
- 17 deposited have been collected on behalf of or for more than one
- 18 benefit plan, the administrator shall maintain the accounts to
- 19 clearly record the deposits in and withdrawals from the account
- 20 on behalf of each benefit plan. The administrator shall promptly
- 21 obtain and keep copies of all such records and, upon request of
- 22 an entity providing a benefit plan, shall furnish the entity
- 23 providing a benefit plan with copies of records pertaining to
- 24 deposits and withdrawals on behalf of or for the benefit plan.
- 25 The administrator shall not pay any claim by withdrawals from
- 26 the fiduciary account. Withdrawals from the fiduciary account
- 27 shall be made, as provided in the written agreement between the
- 28 <u>administrator</u> and the entity providing a benefit plan, for:
- 29 (1) Remittance to a benefit plan entitled thereto.
- 30 (2) Deposit in an account maintained in the name of the

- 1 benefit plan.
- 2 (3) Transfer to and deposit in a claims-paying account.
- 3 (4) Payment to a benefit plan for remittance to an insurer
- 4 <u>entitled thereto.</u>
- 5 (5) Payment to the administrator of its commission, fees or
- 6 charges.
- 7 (6) Remittance of return premiums or charges to the person
- 8 or persons entitled thereto.
- 9 Section 1010. Claim Adjustment and Settlement.--With respect
- 10 to any contracts where an administrator adjusts or settles
- 11 claims, the compensation to the administrator with regard to the
- 12 <u>contracts shall in no way be contingent upon claim experience.</u>
- 13 This section shall not prevent the compensation of an
- 14 administrator from being based upon premiums or charges
- 15 <u>collected or number of claims paid or processed.</u>
- 16 <u>Section 1011. Notification Required.--Where services of an</u>
- 17 <u>administrator are utilized, the administrator shall provide a</u>
- 18 written notice approved by the entity providing the benefit plan
- 19 to persons covered by the benefit plan advising them of the
- 20 <u>identity of and relationship among the administrator, the entity</u>
- 21 providing the benefit plan and the insurer, if any. Where an
- 22 administrator collects funds, it must identify and state
- 23 separately in writing to the person paying any charge or premium
- 24 to the administrator for coverage the amount of any such charge
- 25 or premium specified by the benefit plan for the coverage.
- 26 <u>Section 1012. Regulations; Applicability of Laws.--The</u>
- 27 commissioner may promulgate rules and regulations to implement
- 28 and enforce the provisions of this article. The provisions of
- 29 the act of July 22, 1974 (P.L.589, No.205), known as the "Unfair
- 30 <u>Insurance Practices Act, " shall apply to administrators subject</u>

- 1 to this article.
- 2 <u>Section 1013. Penalties; Suspension and Revocation.--(a)</u>
- 3 Failure to hold a license shall subject the administrator to a
- 4 civil penalty of not less than one thousand dollars (\$1,000) nor
- 5 more than five thousand dollars (\$5,000) for each instance of
- 6 <u>unlicensed activity.</u>
- 7 (b) After notice and hearing, the commissioner may do any
- 8 one or more of the following:
- 9 (1) Suspend, revoke or refuse to renew the license of an
- 10 <u>administrator</u>.
- 11 (2) Impose a civil penalty on an administrator of not more
- 12 than five thousand dollars (\$5,000) for each violation.
- 13 (3) Order restitution upon finding that the administrator
- 14 violated any of the requirements of this act or regulations or
- 15 the administrator is not competent, trustworthy, financially
- 16 <u>responsible or of good personal and business reputation. All</u>
- 17 proceedings shall be pursuant to 2 Pa.C.S. (relating to
- 18 administrative law and procedure).
- 19 Section 4. This act shall take effect in 60 days.
