## AN ACT

- Amending the act of June 27, 1939 (P.L.1199, No.404), entitled 2 "An act relating to the assessment of real and personal 3 property and other subjects of taxation in counties of the first class; providing for the appointment of members of the board of revision of taxes by the judges of the courts of 5 common pleas; providing for the appointment, by the board, of 7 personal property assessors, real estate assessors and 8 assistant real estate assessors, clerks and other employes; 9 fixing the salaries of members of the board, assessors and 10 assistant assessors, and providing for the payment of 11 salaries and expenses from the county treasury; prescribing 12 the powers and duties of the board and of the assessors, the 13 time and manner of making assessments, of the revision and 14 notice of assessments and of appeals therefrom; prescribing 15 the records of assessments; and repealing existing laws," 16 prohibiting spot reassessment.
- 17 The General Assembly of the Commonwealth of Pennsylvania
- 18 hereby enacts as follows:
- 19 Section 1. Section 1.1 of the act of June 27, 1939
- 20 (P.L.1199, No.404), entitled "An act relating to the assessment
- 21 of real and personal property and other subjects of taxation in
- 22 counties of the first class; providing for the appointment of
- 23 members of the board of revision of taxes by the judges of the

- 11 a definition to read:
- 12 Section 1.1. The following words and phrases when used in
- 13 this act shall have, unless the context clearly indicates
- 14 otherwise, the meanings given to them in this section:
- 15 \* \* \*
- 16 <u>"Spot reassessment" shall mean the reassessment of a</u>
- 17 property or properties that is not conducted as part of a
- 18 county-wide revised reassessment and which creates, sustains or
- 19 increases disproportionality among properties' assessed values.
- 20 Section 2. Section 13 of the act is amended by adding a
- 21 subsection to read:
- 22 Section 13. \* \* \*
- 23 (e) The board shall not engage in the practice of spot
- 24 reassessment. In the event that the board does engage in the
- 25 practice of spot reassessment, the property owner may appeal the
- 26 assessment to the board or to the court as set forth in this
- 27 act. Upon a finding by the board or an adjudication by the court
- 28 that the property owner has been subjected to a spot
- 29 reassessment, the property owner shall be entitled to a refund
- 30 of any taxes paid pursuant to a spot reassessment and interest

- 1 thereon at the same rate and in the same manner as the
- 2 <u>Commonwealth is required to pay interest pursuant to section</u>
- 3 806.1 of the act of April 9, 1929 (P.L.343, No.176), known as
- 4 <u>"The Fiscal Code."</u>
- Section 3. This act shall take effect in 60 days. 5
