- 2 Section 1. Be it enacted, &c., That the Pennsylvania State
- 3 Police shall have the power, and its duty shall be, to conduct
- 4 at the Pennsylvania State Police Academy courses of instruction
- 5 for the proper training of persons, not exceeding thirty-four
- 6 years of age, to act as policemen for the several political
- 7 subdivisions of this Commonwealth. Subject to the provisions of
- 8 this act, the Commissioner of Pennsylvania State Police is
- 9 hereby authorized to establish standards of proficiency,
- 10 training and discipline for persons attending such school, and
- 11 to issue certificates of qualification to graduates of the
- 12 various courses of instruction. The Commissioner, with the
- 13 approval of the Governor, shall employ such instructors and
- 14 other employes as may be necessary for the purposes of this act.
- 15 Section 2. This act shall take effect in 60 days.
