## AN ACT

- Amending the act of July 15, 1976 (P.L.1036, No.208), entitled, as amended, "An act authorizing the indebtedness, with the approval of the electors, of fifty million dollars for loans 3 to volunteer fire companies, volunteer ambulance services and 4 volunteer rescue squads for the purpose of establishing or 6 modernizing facilities to house fire fighting apparatus equipment, ambulances, and rescue vehicles, and for 7 8 purchasing new fire fighting apparatus equipment, ambulances, and rescue vehicles, protective and communications equipment, and any other accessory equipment necessary for the proper performance of such organizations' duties," further providing 10 11 for loan assistance to volunteer fire companies, ambulance 12 13 service and rescue squads.
- 14 The General Assembly of the Commonwealth of Pennsylvania
- 15 hereby enacts as follows:
- 16 Section 1. Section 4(b) of the act of July 15, 1976
- 17 (P.L.1036, No.208), known as the Volunteer Fire Company,
- 18 Ambulance Service and Rescue Squad Assistance Act, amended July
- 19 11, 1990 (P.L.415, No.100), is amended to read:

- 1 Section 4. Assistance to Volunteer Fire Companies, Ambulance
- 2 Service and Rescue Squads. --\* \* \*
- 3 (b) {Loans made by the department in the amount of [\$100,000 <--
- 4 or more shall be for a period of not more than 15 years, loans
- 5 less than \$100,000 shall be for a period of ten years, and any
- 6 loan of the amount of] \$15,000 or less shall be for a period of <--
- 7 not more than five <del>years.]</del> YEARS. <u>LOANS MADE BY THE DEPARTMENT</u> <-
- 8 IN EXCESS OF \$15,000 BUT FOR \$50,000 OR LESS SHALL BE FOR A
- 9 PERIOD OF NOT MORE THAN 10 YEARS. The payback period of any loan
- 10 in excess of \$50,000 shall be negotiated between the volunteer
- 11 <u>fire company, ambulance service or rescue squad receiving the</u>
- 12 loan and the department BUT SHALL NOT EXCEED 15 YEARS. Loans
- 13 shall be subject to the payment of interest at 2% per annum and
- 14 shall be subject to such security as shall be determined by the
- 15 department. The total amount of interest earned by the
- 16 investment or reinvestment of all or any part of the principal
- 17 of any loan shall be returned to the department and transferred
- 18 to the Volunteer Companies Loan Fund, and shall not be credited
- 19 as payment of principal or interest on the loan. The minimum
- 20 amount of any loan shall be \$5,000.

- 22 Section 2. This act shall take effect in 60 days.
