AN ACT

- Amending the act of July 9, 1959 (P.L.510, No.137), entitled, as 2 amended, "An act relating to the public lands of the Commonwealth; defining such land; providing for the sale of 3 vacant and unimproved public lands and the price to be paid 5 therefor; providing for the conveyance of title to vacant and unappropriated public land to the Department of Forests and 7 Waters for forest culture, forest reservation, or State park purposes; providing for the conveyance of title to all public 8 9 lands for which applications have been made or warrants issued and to all persons having rights by settlement and 10 improvement upon payment of the purchase price; providing for 11 the release of liens for unpaid purchase price in certain 12 cases; preventing the granting of title to lands and islands 13 14 in the bed of navigable rivers and streams declared by law to be public highways except in certain cases; and prescribing 15 the duties of the Department of Community Affairs with 16 respect to the administration of the public lands and the 17 18 records thereof, including surveys of county and Commonwealth 19 boundaries and documents having to do with early titles," providing for appraisal fees. 20
- 21 The General Assembly of the Commonwealth of Pennsylvania
- 22 hereby enacts as follows:
- 23 Section 1. Section 8 of the act of July 9, 1959 (P.L.510,
- 24 No.137), known as the Pennsylvania Public Lands Act, is amended
- 25 to read:
- 26 Section 8. Board of Appraisers. -- Upon application for vacant

- 1 land, the land shall be appraised by a board of appraisers,
- 2 comprising three disinterested persons appointed by the
- 3 department, who are residents of the county or counties wherein
- 4 the land is situate, of whom one shall be an attorney at law who
- 5 shall act as chairman, one a registered professional engineer,
- 6 and one a licensed real estate broker.
- 7 The person so appointed shall swear or affirm, before an
- 8 officer authorized to administer oaths, faithfully to perform
- 9 the duties herein prescribed, and that they are not directly or
- 10 indirectly interested in the application. They shall proceed to
- 11 value the land by going upon it and taking into consideration
- 12 soil, timber, fisheries, minerals, location and other
- 13 advantages, and shall determine the value thereof. In the case
- 14 of improved land, the value of the improvements shall not be
- 15 included in the valuation. The chairman of the board shall
- 16 prepare and transmit the report of the board to the department.
- 17 Having agreed upon the valuation, the chairman shall certify the
- 18 same to the department in his report within thirty days after
- 19 the appointment of the board. If any of the board of appraisers
- 20 so appointed shall fail, neglect or refuse to perform any of
- 21 their duties within thirty days of their appointment, the
- 22 department may vacate the appointment and appoint another board
- 23 of appraisers to perform the work in the same manner as the
- 24 original board. The members of the board shall be entitled to a
- 25 fee [of twenty-five dollars (\$25.00) each and the chairman shall
- 26 receive an additional twenty-five dollars (\$25.00) for the
- 27 preparation of the report] in an amount as agreed upon by the
- 28 Pennsylvania Historical and Museum Commission, the board of
- 29 appraisers and the applicant.
- 30 Section 2. This act shall take effect in 60 days.
