- 9 WHEREAS, Pennsylvania State Police and municipal police
- 10 officers often put their lives at risk while upholding the laws

- 1 of the Commonwealth; and
- 2 WHEREAS, Pennsylvania State Police and municipal police
- 3 officers wounded in the line of duty warrant the awarding of a
- 4 citation; therefore be it
- 5 RESOLVED, That the House of Representatives shall award
- 6 citations to Pennsylvania State Police and municipal police
- 7 officers wounded in the line of duty; and be it further
- 8 RESOLVED, That citations may be requested by members of the
- 9 House of Representatives to honor Pennsylvania State Police and
- 10 municipal police officers wounded in the line of duty.
