A RESOLUTION

1 Declaring the week of October 17 through 24, 1993, as "National
2 Business Women's Week" in Pennsylvania.

3 WHEREAS, "National Business Women's Week" was first observed
4 by the National Federation of Business and Professional Women's
5 Clubs, Inc., in 1928, and has since become a nationwide salute
6 to working women; and

7 WHEREAS, The purpose of the Business and Professional Women's
8 Organization is to promote full participation, equity and
9 economic self-sufficiency for women; and

10 WHEREAS, The Pennsylvania Federation of Business and
11 Professional Women, a charter member of the National Federation,
12 supports and promotes National, State and local projects or

1 programs that will advance the cause of improving the status of
2 the person, male or female, employed in business or a
3 profession; therefore be it

4 RESOLVED, That the House of Representatives declare the week
5 of October 17 through 24, 1993, as "National Business Women's
6 Week" in Pennsylvania.
