AN ACT

- 1 Providing for subsidized child care for caregivers enrolled in approved training programs.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Definitions.
- 6 The following words and phrases when used in this act shall
- 7 have the meanings given to them in this section unless the
- 8 context clearly indicates otherwise:
- 9 "Caretaker." The applicant for child day-care service with
- 10 whom the child lives and who is the individual responsible for
- 11 documenting family eligibility for subsidized child day-care
- 12 service.
- "Child day-care service." Out-of-home care provided for part
- 14 of the 24-hour day and approved by the Department of Public
- 15 Welfare, including, but not limited to, care in a child day-care

- 1 center, group child day-care home or family child day-care home.
- 2 "Department." The Department of Public Welfare of the
- 3 Commonwealth.
- 4 "Subsidized child day care." Child day-care service, paid
- 5 for in part or in full with Federal or State funds, provided to
- 6 enable the caretaker of a child to be employed or receive job
- 7 training.
- 8 "Training program." An institutional program which enables
- 9 the caretaker to establish a basic level of education, to
- 10 establish basic skills in the English language or to attain
- 11 skills which qualify the individual for a specific job. The term
- 12 includes programs which lead to an associate degree or a
- 13 baccalaureate degree.
- 14 Section 2. Approved training programs for subsidized child
- 15 care.
- 16 (a) Requirement of caregiver regarding enrollment.--A
- 17 caretaker who is enrolled in a training program enumerated in
- 18 subsection (b) and who provides the department with verification
- 19 of enrollment as prescribed by the department shall be
- 20 considered to meet the training requirements necessary to
- 21 qualify for subsidized child care.
- 22 (b) Enumeration of training programs. -- The following qualify
- 23 as approved training programs:
- 24 (1) Completion of junior high school.
- 25 (2) Completion of high school.
- 26 (3) Remedial courses at a secondary or postsecondary
- 27 level required for entrance into an accredited training
- 28 program.
- 29 (4) A training program at a postsecondary level which
- 30 leads to a specific job.

- 1 (5) General education development (GED) training for 20
- 2 or more hours per week.
- 3 (6) English as a second language training for 20 or more
- 4 hours per week.
- 5 (7) A 2-year associate degree program which qualifies an
- 6 individual for a specific job.
- 7 (8) A 4-year baccalaureate degree program at a college
- 8 or university which qualifies an individual for a specific
- 9 job.
- 10 (c) Other requirements.--In addition to compliance with
- 11 training requirements, the caretaker shall reside in this
- 12 Commonwealth and shall meet financial eligibility requirements
- 13 established in department regulations.
- 14 Section 3. Department's responsibility to establish waiting
- 15 list service priorities.
- 16 The department shall determine by regulation service
- 17 priorities for the children of eligible caretakers who are
- 18 placed on a waiting list because public funds for services are
- 19 not available to enroll the children in approved child day-care
- 20 programs. The service priorities shall include employment,
- 21 training and income criteria.
- 22 Section 4. Effective date.
- 23 This act shall take effect in 60 days.
