AN ACT

- Amending Title 23 (Domestic Relations) of the Pennsylvania
 Consolidated Statutes, prohibiting the enforcement of
 contracts which purport to employ a surrogate mother for the
 sole purpose of pregnancy and delivery of a baby.

- 7 Section 1. Chapter 23 of Title 23 of the Pennsylvania
- 8 Consolidated Statutes is amended by adding a subchapter to read:

- 13 § 2331. Unenforceability of contract.
- 14 (a) General rule. -- A contract purporting to employ a woman
- 15 to act as a surrogate mother for the sole purpose of pregnancy
- 16 and delivery of a baby is unenforceable. Neither relinquishment
- 17 of the baby nor payment of a fee for surrogacy shall be
- 18 enforceable in any court of this Commonwealth.

- 1 (b) Effect of unenforceability. -- Such a contract is null and
- 2 void ab initio.
- 3 (c) Parenthood.--A woman who consents to carry and deliver a
- 4 baby for another is the legal mother of that baby. If she is
- 5 married, her husband shall be deemed to be the legal father of
- 6 that baby. If she is not married, the sperm donor shall be
- 7 deemed to be the legal father of that baby. For the legal
- 8 parents to relinquish legal custody of that baby, they shall be
- 9 required to terminate parental rights in accordance with 23
- 10 Pa.C.S. Part III (relating to adoption).
- 11 (d) Social services investigation. -- In the course of any
- 12 adoption proceeding which arises from a surrogacy birth, a full
- 13 investigation of all parties terminating legal custody and of
- 14 all parties seeking legal custody shall occur, and the
- 15 investigator shall make a report of this investigation to the
- 16 court that presides over adoption proceedings. The report shall
- 17 include, but not be limited to, a recommendation of court
- 18 action.
- 19 Section 2. This act shall take effect in 60 days.
