AN ACT

- 1 Providing for dual party relay services and for
- telecommunication device distribution.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Dual Party
- 7 Relay Service and Telecommunication Device Distribution Program
- 8 Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- "Center for independent living." A consumer-controlled,
- 14 community-based, cross-disability, nonresidential private,
- 15 nonprofit agency that is designed and operated within a local
- 16 community by people with disabilities and provides an array of

- 1 independent living services, as defined by the Rehabilitation
- 2 Act of 1973 (Public Law 93-112, 29 U.S.C. § 701 et seq.).
- 3 "Commission." The Pennsylvania Public Utility Commission.
- 4 "Department." The Department of Labor and Industry of the
- 5 Commonwealth.
- 6 "Persons with a disability" or "people with disabilities." A
- 7 person certified as being deaf, deaf-blind, hard-of-hearing,
- 8 having a hearing loss or speech impaired by a licensed
- 9 physician, audiologist, speech pathologist or a qualified State
- 10 agency.
- 11 "Program." The Telecommunication Device Distribution Program
- 12 established under this act.
- "Telecommunication device." Equipment necessary for a person
- 14 with a disability to engage in communication by wire or radio
- 15 with another person with a disability or with a hearing
- 16 individual.
- 17 "Telecommunication relay service." Telephone transmission
- 18 services that provide the ability for a person with a disability
- 19 to engage in communication by wire or radio with a hearing
- 20 individual in a manner that is functionally equivalent to the
- 21 ability of a person who does not have a disability to
- 22 communicate using voice communication services by wire or radio.
- 23 The term includes services that enable two-way communication
- 24 between an individual who uses a telecommunication device or
- 25 other nonvoice terminal device and an individual who does not
- 26 use such a device.
- 27 Section 3. Establishment of Telecommunication Device
- 28 Distribution Program.
- 29 (a) Establishment.--The Telecommunication Device
- 30 Distribution Program is hereby established. It shall be a

- 1 program whereby telecommunication devices for people with
- 2 disabilities are distributed at no charge to the distributee.
- 3 (b) Administration. -- The executive director of the Office of
- 4 Vocational Rehabilitation of the department, in cooperation with
- 5 other State agencies which serve people with disabilities, shall
- 6 oversee implementation of the program. To this end, the
- 7 executive director may do any of the following:
- 8 (1) Establish criteria of eligibility in accordance with
- 9 subsection (c) and adopt regulations and forms consistent
- 10 with the act of July 31, 1968 (P.L.769, No.240), referred to
- 11 as the Commonwealth Documents Law.
- 12 (2) Facilitate coordination of funds required for the
- distribution system with selected centers for independent
- 14 living.
- 15 (3) Determine, in cooperation with other State agencies,
- the funds required for the distribution system and provide
- information to the commission as required under section 4.
- 18 (c) To qualify as distributee. -- Each recipient of a
- 19 telecommunication device shall meet the following criteria:
- 20 (1) Be a resident of this Commonwealth.
- 21 (2) Qualify as a person with a disability.
- 22 (3) Have telephone service, possess the ability to learn
- 23 how to use a telecommunication device.
- 24 (4) Be six years of age or older.
- 25 (5) Have a gross income of less than 200% of the Federal
- 26 poverty level as determined in accordance with the Link Up
- 27 America guidelines.
- 28 Section 4. Establishment of dual party relay service.
- 29 (a) Telecommunication relay services. -- The commission shall
- 30 design and implement a telecommunication relay service program

- 1 for the Commonwealth that is consistent with and meets or
- 2 exceeds the requirements of the Americans with Disabilities Act
- 3 of 1990 (Public Law 101-336, 104 Stat. 327).
- 4 (b) Certification.--The commission is authorized to seek on
- 5 behalf of this Commonwealth certification of the
- 6 telecommunication relay service program from the Federal
- 7 Communications Commission.
- 8 (c) Additional use of surcharge. -- The program shall be
- 9 funded by the Telecommunication Relay Service Program surcharge,
- 10 as calculated by the commission on an annual basis under the
- 11 methodology established by the commission in order entered May
- 12 29, 1990, and July 9, 1990, at Docket Number M900239. The
- 13 executive director of the Office of Vocational Rehabilitation in
- 14 the department shall provide the commission with an annual
- 15 budget and supporting information for the purchase of
- 16 telecommunication devices for the program. The surcharge shall
- 17 not be used to fund administrative costs of the program.
- 18 (d) Limits on expenditures.--Expenditures for the program
- 19 shall not exceed collections from the Telecommunication Relay
- 20 Service Program surcharge.
- 21 (e) Annual report. -- The commission shall prepare and submit
- 22 an annual report to the General Assembly on the program.
- 23 (1) The report shall include the fiscal status of the
- 24 program, a statement of the surcharge level established under
- subsection (c) and the revenues produced by the surcharge, an
- account of program expenses and the fund balance.
- 27 (2) The executive director of the Office of Vocational
- 28 Rehabilitation in the department shall provide the commission
- 29 with information on the program, including the purchase and
- 30 distribution of telecommunication devices, for inclusion in

- 1 the annual report to the General Assembly.
- 2 (3) If the commission determines any of the information
- 3 is proprietary, the information shall be filed under seal and
- 4 made available under the terms of an appropriate protective
- 5 agreement of the type used in cases before the commission.
- 6 Section 5. Effective date.
- 7 This act shall take effect immediately.
