- 9 Section 1. Section 3 of the act of July 22, 1974 (P.L.589,
- 10 No.205), known as the Unfair Insurance Practices Act, is amended
- 11 by adding definitions to read:

- 1 Section 3. Definitions.--As used in this act:
- 2 <u>"Abuse" has the meaning given in 23 Pa.C.S. § 6102(a)</u>
- 3 (relating to definitions), notwithstanding the limited
- 4 applicability provision in 23 Pa.C.S. § 6102(a)(5).

- 6 "Family or household members" has the meaning given in 23
- 7 Pa.C.S. § 6102 (a) (relating to definitions).

- 9 "Victim" means an individual who is or has been subjected to
- 10 <u>abuse</u>.
- 11 <u>"VICTIM OF ABUSE" MEANS AN INDIVIDUAL WHO IS A VICTIM OR AN</u> <—
- 12 INDIVIDUAL WHO SEEKS OR HAS SOUGHT MEDICAL OR PSYCHOLOGICAL
- 13 TREATMENT FOR ABUSE, PROTECTION FROM ABUSE OR SHELTER FROM
- 14 ABUSE.
- 15 Section 2. Section 5(a) of the act is amended by adding a
- 16 paragraph to read:
- 17 Section 5. Unfair Methods of Competition and Unfair or
- 18 Deceptive Acts or Practices Defined. -- (a) "Unfair methods of
- 19 competition" and "unfair or deceptive acts or practices" in the
- 20 business of insurance means:

- 22 (14) (I) Taking any of the following actions because the
- 23 insured or applicant for an insurance policy or insurance
- 24 contract is a victim or because the insured or applicant for an

- 26 <u>medical or psychological treatment for abuse, protection from</u>
- 27 abuse or shelter from abuse: VICTIM OF ABUSE:
- 28 (i) (A) Denying, refusing to issue, refusing to renew,
- 29 refusing to reissue or cancelling or terminating an insurance
- 30 policy or insurance contract or restricting coverage under an

- 1 insurance policy or insurance contract.
- 2 (ii) (B) Adding a surcharge, applying a rating factor or <--
- 3 using any other underwriting standard or practice which
- 4 adversely takes into account a history or status of abuse.
- 5 (iii) (C) Excluding or limiting benefits or coverage under <--
- 6 <u>an insurance policy or insurance contract for losses incurred.</u>
- 7 (II) NOTHING IN THIS PARAGRAPH SHALL BE CONSTRUED AS:
- 8 (A) REQUIRING THAT A PERSON ISSUE, RENEW OR REISSUE AN
- 9 <u>INSURANCE POLICY OR INSURANCE CONTRACT SOLELY BECAUSE THE</u>
- 10 INSURED OR APPLICANT IS A VICTIM OF ABUSE; OR
- 11 (B) REQUIRING A PERSON TO PROVIDE BENEFITS OR COVERAGE FOR
- 12 LOSSES INCURRED SOLELY BECAUSE THE INSURED OR APPLICANT IS A
- 13 <u>VICTIM OF ABUSE</u>.
- 14 (III) A PERSON SHALL NOT BE IN VIOLATION OF THIS PARAGRAPH
- 15 IF ANY ACTION TAKEN IS PERMISSIBLE BY LAW AND APPLIES TO THE
- 16 SAME EXTENT TO ALL APPLICANTS AND INSUREDS WITHOUT REGARD TO
- 17 WHETHER AN APPLICANT OR INSURED IS A VICTIM OF ABUSE.

- 19 Section 3. This act shall take effect immediately.
