AN ACT

- 1 Amending Title 24 (Education) of the Pennsylvania Consolidated 2 Statutes, further providing for creditable nonschool service.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Section 8304(b) and (c) of Title 24 of the
- 6 Pennsylvania Consolidated Statutes are amended to read:
- 7 § 8304. Creditable nonschool service.
- 8 * * *
- 9 (b) Limitations on nonschool service.--Creditable nonschool
- 10 service credit shall be limited to:
- 11 (1) Intervening military service.
- 12 (2) Military service other than intervening military
- 13 service and activated military service not exceeding five
- 14 years provided that a member with multiple service may not
- 15 purchase more than a total of five years of military service
- in both the system and the State Employees' Retirement
- 17 System.

- 1 (3) Service in any public school or public educational 2 institution in any state other than this Commonwealth or in 3 any territory or area under the jurisdiction of the United 4 States. This paragraph includes service, prior to July 1, 5 1965, at a community college established under the act of
- 6 August 24, 1963 (P.L.1132, No.484), known as the Community
- 7 College Act of 1963.

- 8 (4) Service as an administrator, teacher, or instructor 9 in the field of public school education for any agency or 10 department of the government of the United States whether or 11 not such area was under the jurisdiction of the United 12 States.
 - (5) Previous service as an employee of a county board of school directors which employment was terminated because of the transfer of the administration of such service or of the entire agency to a governmental entity.
 - (6) Previous service as a county employee as a nurse. For every three years or major fraction thereof in previous work experience, an individual may buy one year of creditable service, not to exceed a total of five years. The purchase of this service shall begin within three years of the employee's eligibility to purchase this creditable service.
- 23 (7) Service for the period of time spent on a maternity
 24 leave of absence required by the employer, which creditable
 25 service shall not exceed two years per leave and shall be
 26 applicable only to a maternity leave which was mandatory
 27 prior to May 17, 1975. The purchase of this service shall
 28 begin within one year of the employee's eligibility to
 29 purchase this creditable service.
- 30 (8) Service in the Cadet Nurse Corps with respect to any 19950H1702B2050 2 -

- 1 period of training as a student or graduate nurse under a
- 2 plan approved under section 2 of the act of June 15, 1943
- 3 (Public Law 78-73, 57 Stat. 153), if the total period of
- 4 training under the plan was at least two years, the credit
- 5 for such service not to exceed three years.
- 6 (9) Previous service as an administrator, teacher or
- 7 <u>instructor in any public, American or international school,</u>
- 8 or public, American or international educational institution
- 9 in any territory or area not under the jurisdiction of the
- 10 Federal Government, provided that such school or institution
- 11 was accredited by the Middle States Association of Colleges
- 12 <u>and Secondary Schools or any other United States regional</u>
- accrediting entity during the time of the employee's service.
- 14 (c) Limitations on years of credit.--Service listed in
- 15 subsection (b)(3) [and], (4) and 9 must have been for a period
- 16 of at least one school year and credit for such service shall be
- 17 limited to the lesser of 12 years or the number of years of
- 18 school service credited in the system. In no case shall the
- 19 total credit for nonschool service other than that listed in
- 20 subsection (b)(5) exceed the number of years of school service
- 21 credited in the system, plus, in the case of a multiple service
- 22 member, any additional years of State service credited in the
- 23 State Employees' Retirement System.
- 24 Section 2. This act shall take effect immediately.
