## AN ACT

1 2 3 4 5	Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, providing for the seizure and forfeiture of vehicles used in the commission of the offense of driving under the influence of alcohol or a controlled substance in certain cases.
б	The General Assembly of the Commonwealth of Pennsylvania
7	hereby enacts as follows:
8	Section 1. Section 3731 of Title 75 of the Pennsylvania
9	Consolidated Statutes is amended by adding a subsection to read:
10	§ 3731. Driving under influence of alcohol or controlled
11	substance.

13	(j) Seizure and forfeiture of vehicle
14	(1) In addition to any other penalty provided by law, a
15	law enforcement agency shall seize the vehicle used in the
16	course of an offense that results in a conviction for any of
17	the following offenses if the vehicle is owned by the
18	defendant at the time of the offense:
19	(i) A third conviction of violating this section

1	within ten years after the date of a prior conviction for
2	violating this section.
3	(ii) A fourth or subsequent conviction of violating
4	this section.
5	(iii) A conviction of violating section 3735
б	(relating to homicide by vehicle while driving under
7	<u>influence).</u>
8	(2) For the purposes of this subsection, a prior
9	conviction for violating any former provision of the laws of
10	this Commonwealth relating to driving a vehicle while under
11	the influence of alcohol or a controlled substance or a prior
12	conviction outside of this Commonwealth for an alcohol-
13	related or drug-related traffic offense that is substantially
14	similar to an offense under this section shall be deemed to
15	be a prior conviction.
16	(3) For the purposes of this subsection, a vehicle
17	seized under this subsection shall be forfeited in accordance
18	with the provisions of 42 Pa.C.S. Ch. 68 (relating to
19	controlled substances forfeitures) unless the court
20	determines that forfeiture of the vehicle would impose undue
21	hardship on the family of the owner of the vehicle and that
22	other means are unavailable to the owner's family for
23	necessary travel.
24	Section 2. This act shall take effect in 60 days.
