AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 2 act relating to the public school system, including certain 3 provisions applicable as well to private and parochial 4 schools; amending, revising, consolidating and changing the 5 laws relating thereto, " providing for assemblies on child abuse prevention. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. The act of March 10, 1949 (P.L.30, No.14), known
- 10 as the Public School Code of 1949, is amended by adding a
- 11 section to read:
- 12 Section 1550. Child Abuse Prevention Assemblies. -- (a)
- 13 Beginning with the 1996-1997 school year and each year
- 14 thereafter, each public school shall hold at least one school
- 15 assembly on child abuse prevention. Each assembly presentation
- 16 shall be age designed so that the information made available
- 17 could be easily understood by the population to which the
- 18 presentation would be made.
- 19 (b) Prior notification shall be made to parents/quardians of

- 1 children who would participate in such assemblies, in order to
- 2 ensure that those who would like specific information on the
- 3 content of the assemblies could request and receive it. In
- 4 addition, parents and guardians shall have the option of
- 5 choosing to not have their child participate in the child abuse
- 6 prevention assembly. Parents/quardians choosing to not have
- 7 their child participate shall provide written notification to
- 8 the building principal, who shall provide for alternative
- 9 <u>arrangements for those children not participating in the</u>
- 10 <u>assemblies</u>.
- 11 (c) School districts may utilize any appropriate public or
- 12 private materials, personnel and other resources in developing
- 13 and implementing the presentation of child abuse prevention
- 14 assemblies. In addition, school districts shall work
- 15 cooperatively with parent-teacher organizations in the planning
- 16 of assemblies on child abuse prevention, including the selection
- 17 of materials to be presented. The Department of Health,
- 18 Department of Education and Department of Public Welfare shall
- 19 make available, upon request, information about appropriate
- 20 <u>child abuse prevention assembly materials.</u>
- 21 (d) Child abuse prevention assembly presentations shall
- 22 include, but not be limited to: information and instruction on
- 23 the right of bodily privacy, the dangers presented by abusers
- 24 and abductors and the techniques of avoiding victimization.
- 25 Section 2. This act shall take effect in 60 days.
